**Subject: Revocation/Withdrawal of the post of Junior Assistant, District Cadre Doda
Advertisement Notification No. 03 of 2015 dated 08.08.2015 Item No. 85**

Whereas, the J&K Services Selection Board advertised various posts including two posts (OM=02) of Junior Assistant, District Cadre Doda, Industries and Commerce Department vide Advertisement Notification No. 03 of 2015 dated 08.08.2015, Item No. 85; and

Whereas, upon verification it has come to fore that the aforesaid two posts of Junior Assistant, District Cadre Doda belonging to the Industries and Commerce Department have been inadvertently notified under Advertisement Notification No. 03 of 2015 dated 08.08.2015, Item No. 85 as the aforesaid two posts of Junior Assistant had already advertised pursuant to Advertisement Notification No. 02 of 2015, Item No. 66 dated 12.06.2015, Industries and Commerce Department, District Cadre Doda; and


Whereas, the selection against the two posts of Junior Assistants as notified vide Advertisement Notification No. 02 of 2015, under Item No. 66, Industries and Commerce Department, District Cadre Doda has already been finalized and forwarded to the Indenting department vide communication No. SSB/Secy/Sel/2018/1971-77 dated 19.02.2018; and

Whereas, it is not legally tenable to advertise one and the same post twice for the purpose of making selection without a valid requisition from the Indenting Department and also owing to the reason that selection has already been made for the posts and that an erroneous process, even if taken to logical conclusion does not confer indefensible right to claim appointment upon any person; and

Whereas, it is a settled position of law that a candidate does not acquire any right merely by applying for selection or even after selection and that the recruiting agency can at any time, before forwarding the final Selection List to the Government for issuing formal appointment orders, withdraw the advertised posts for any valid and justified reason.

Now, therefore, in view of the aforesaid facts and circumstances, the post of Junior Assistant, Industries and Commerce Department, District Cadre Doda advertised vide Item No. 85(03 of 2015) inadvertently and erroneously shall stand withdrawn/cancelled ab-initio.
