



- 1/ Whereas, the J&K Services Selection Board issued final selection list of the candidates for the post of "**Electrician/Line Man**" (Health & Medical Education Department, GMC Anantnag), item No. 041 (01 of 2019) Divisional Cadre Kashmir and recommended the same to the Health & Medical Education Department vide letter No. SSB/Secy/Sel/40(k)/2020/2302-08 dated 13.03.2020 for further course of action; and
- 2/ Whereas, among others, the recommendation of one candidate namely **Owais Mushtaq Rather S/O Mushtaq Ahmad Rather** figuring at **S.No.01/OM/RBA category** has been kept withheld subject to clarification with regard to equivalence of course with the required qualification as per notification and clarification regarding course from Women ITI Kangan; and
- 3/ Whereas, the notice was issued to the candidate vide this office No.SSB/Secy/39/2020/4491-94 dated 03.12.2020 for furnishing documents within 07 days, which evoked no response.
- 4/ Whereas, the candidate has furnished an undertaking of non joining duty sworn before a Judicial Magistrate Ist class Srinagar mentioning therein that the deponent has no objection or claim in future if waiting candidate will be adjusted against his position in GMC Anantnag as he wants to join as Electrician/Line Man at GMC Baramulla; and
- 5/ Whereas, the case was processed in 177<sup>th</sup> Board meeting wherein it was decided that the candidature of the candidate for the post of "Electrician/Line Man" (Health & Medical Education Department, GMC Anantnag), item No. 041 (01 of 2019) Divisional Cadre Kashmir is cancelled.
