Subject: Submission of Offline forms for Appellants in light of order dated 31.12.2020 passed by Hon'ble Division Bench in LPA No.169/2020 titled Bhupender Singh Jamual and Others.

Whereas, the J&K Services Selection Board (JKSSB) invited online applications vide Advertisement No. 03 of 2020 dated 01.12.2020 from eligible candidates for participating in the selection process for Divisional/District Cadre Posts of various categories in different Departments under PM Special Package for Kashmiri migrants and Non-Migrant Kashmiri Pandits; and

Whereas, the date of commencement for submission of online applications was 07-12-2020 and the last Date for submission of online applications was fixed as 21-12-2020; and

Whereas, the Divisional Commissioner and Deputy Commissioner Srinagar forwarded representations of President Kashmiri Sangarsh Samiti vide letter No. Div.Com/PS/Misc/2020/2341-47 dated: 09-12-2020 and ADC-S/PS/Misc/2020-21/2845-49 dated: 08-12-2020 respectively for seeking extension in the last date for submission of online application forms for the Notification No. 03 of 2020 dated 01-12-2020 ;and

Whereas, the last ^{date} for submission of online applications for posts advertised vide Advertisement Notice No. 03 of 2020 dated 01.12.2020 was earlier extended to 05-01-2021 vide Notification No.SSB/Sel/Secy/20/4765-80 dated:11-12-2020 and which has again been extended upto 25-01-2021 vide this offices Notification No. SSB/Secy/2021/59-75 Dated: - 04.01.2021;and

Whereas, President Kashmiri Sangarsh Samiti submitted representation dated 31-12-2020 seeking for extension of last date for submission of online applications for the posts advertised in Notification No. 03 of 2020 at least by 30 days;and


Whereas, the Hon'ble High Court passed order dated 31-12-2020 by Division Bench of Hon'ble High Court in LPA No. 169/2020 titled Bhupender Singh Jamual and others V/s Union Of India and others, directed that

"...Secretary, J&K Services Selection Board shall entertain the candidature of the appellants at their own risk and responsibility and provisionally subject to further directions from this Court. The appellants participation in the selection process shall not create any right on them which will be subject to decision by this Court and in the event, the respondents are in the process of finalizing the selection, the appellants result shall be kept in a sealed cover."

Whereas, the matter has been examined by the Board and it has been decided to take Offline Forms from all the twelve Appellants as referred in LPA No. 169/2020 titled Bhupendar Singh Jamual and other V/s Union of India & others; and

Now, therefore, in the light of above, the appellants of LPA No. 169/2020 titled Bhupendar Singh Jamual and other V/s Union of India & others are allowed and directed to submit the application form for the posts advertised vide Notification No. 03 of 2020 dated 01-12-2020 by or before 05-02-2020 in the Divisional Office of Administrative Officer of J&K Services Selection Board Srinagar/Jammu, at their own risk and responsibility and their candidature is provisional subject to further directions from the Hon'ble Court, and fulfilment of conditions laid down in relevant rules.

Other terms and conditions as laid down in the afore said notification shall remain unchanged.
