Subject: SWP No. 1922/2019 titled Shruti Saliada V/S State of J&K and Ors.

Whereas, the Jammu & Kashmir Services Selection Board advertised various post including the post of Junior Assistant, (School Education Department) District Cadre, Kathua under Item No 78 pursuant to Advertisement Notice No. 01 of 2016 dated 01.06.2016 with the following breakup of posts RBA=03,SC=01,ST=02,ALC=01,OSC=01 Total=08

Whereas, after completion of the selection process, the Selection List was issued and the same was forwarded to the Indenting Department vide Communication No. SSB/Secy/Sel/2018/8187-93 dated 11.07.2018.

Whereas the candidate namely Deepak Jyoti D/o Amar Nath was selected under OSC Category figuring at Serial No. 01 but her recommendation was kept withheld subject to production of within date valid OSC Category Certificate and the candidate namely Shruti Saliada was figured in the waiting list under OSC Category whose recommendation was withheld and subject to production of PRC Certificate/ Premarital Category Certificate and Validity of Computer Diploma.

Whereas, the candidate namely Shruti Saliada, approached the Hon'ble High Court by way of SWP No. 1922/2019 titled 'Shruti Saliada V/S State and others, which was disposed of by the Hon'ble High Court vide judgment dated 25.02.2019 with the following directions:-


"Let a decision in this regard be taken by the respondent No. 1 within a period of four weeks from the date, a copy of this order is received by him. It would be in the fitness of things to grant one last opportunity to the respondent No. 2 to fulfil the deficiency. Further course of action depends upon the decision as shall be taken by the respondent No. 1"

Whereas, the J&K Services Selection Board served a final notice vide No.SSB/Secy/Sel/2018/5300-03 dated 15.10.2019 to the candidate namely Deepak Jyoti to submit within date valid OSC Category certificate within period of seven days in the J&K Services Selection Board, but she failed to submit the same till date and the J&K Services Selection Board vide Order No.157-SSB of 2020 dated 15-05-2020 cancelled/withdrawn the withheld selection of Deepak Jyoti D/o Amar Nath R/o Mehtapur, District Kathua, J&K figuring at Serial No 01 under OSC Category for the post of Jr. Assistant (School Education Department) District Cadre Kathua under Item No.78 pursuant to Notification No 01/2016 dated 01.06.2016. Whereas, Smt. Shruti Saliada W/o Sohan Lal submitted a representation along with self attested copy of PRC, Social Caste Certificate (OSC), educational qualification documents and requested for revising/modifying of the final Selection List and for release of withheld recommendation.

Whereas, the matter was examined by the J&K Services Selection Board in its 174th meeting held on 16th September, 2020 in compliance to the directions of the Hon'ble High Court, Jammu and the matter was again re-examined by the Board in its 177th meeting held on 22nd and 23rd of December,2020 and after examining the matter, it was noted that the Board is not in a position to recommend the name of the petitioner as she figures in the Combined waiting list which was published on the official website of the Board and was not forwarded to the Indenting department given the fact that the General Administration Department declared the said Combined Waiting List void ab-initio vide their communications No. GAD/Mtg/RB-IV/82/2018 dated 25.03.2019 and Communication No. GAD/Mtg/RB-IV/82/2018 dated 09.10.2020.

Now, therefore, in deference to Judgment/order dated 25.02.2019 passed by the Hon'ble High Court in SWP No 1922/2019 titled Shruti Saliada V/S State and others and as per the decision of the Board, the claim of the petitioner namely Shruti Salida W/o Sohan Lal, R/o Sallan, Tehsil Hiranagar, District Kathua is found devoid of merit and is hereby rejected.
