Subject: SWP No 252/2018 titled Surinder Kumar V/s State of J&K and Ors.

Whereas, the Jammu and Kashmir Services Selection Board vide Advertisement Notification No. 07 of 2015 dated 02.12.2015 under SRO 202 advertised various Posts including the posts of Junior Pharmacist, (Health and Medical Education Department) District Cadre Kupwara under Item No. 686 with the following breakup OM=19, RBA=03, SC=03, ST=03, OSC=01, ALC=01, Total=30; and

Whereas, the Provisional Selection List was issued vide Endorsement No. No.SSB/Sel/Secy/2017/13852-55 dated 30.12.2017 and the revised Provisional List was issued vide order no 82-SSB of 2018 dated 23.01.2018 revising the provisional Selection List under SC Category wherein, it was provided that the Document Verification/Counselling of the Candidate will be held on 02.02.2018 at Central Office, J&K Services Selection Board (the petitioner who applied for the aforesaid post under SC Category called for Document verification vide Notice No. SSB/Secy/Sel/2017/13852-55 dated 30.12.2017 but the petitioner remained absent on the schedule date and therefore was not considered for the posts of Junior Pharmacist, (Health and Medical Education Department) District Cadre Kupwara.);and

Whereas, the petitioner (who applied under SC Category for the above said post) feeling aggrieved upon non-consideration of his candidature and claim regarding Counselling cum Document Verification filed writ petition before the Hon'ble High Court, Jammu bearing SWP No 252/2018 titled Surinder Kumar V/s State of J&K wherein praying for verification of his documents; and

Whereas, the Hon'ble High Court vide order dated 19.02.2018 passed in aforesaid writ petition directed that one post of Junior Pharmacist District Kupwara under SC Category advertised vide Item no 686 of Advertisement Notification No. 07 of 2015 shall not be filled up; and

Whereas, the Hon'ble High Court upon consideration of the writ Petition Vide order dated 31.12.2018 issued the following directions:- **"Keeping in view the aforesaid facts, in my opinion, this petition deserves to be allowed. Ordered accordingly. The board is directed to verify the documents of the petitioner. The petitioner shall appear before the Secretary, Service Selection Board on 07.01.2019 at 11.00 AM for verification of his documents. In case the petitioner is found to be eligible after verification of the documents, necessary action for his appointment shall be taken within two weeks thereafter..."**;and

Whereas, the Jammu and Kashmir Services Selection Board vide communication No. SSB/S 4/18/121/2019 dated 18.01.2019 take up the matter with the General Administration Department and the General Administration Department vide its Communication no. GAD/(L) F-68/2019/1125 dated 21.10.2019, conveyed that the matter has been examined in the General Administration Department in consultation with the Department of Law, Justice and PA, advising the Board to comply with the Court Judgment dated 31.12.2018 and allow the petitioner (Surinder Kumar) to appear in the Board for verification of documents under rules; and

Whereas, the Jammu and Kashmir Services Selection Board in its 159th meeting held on 14th December, 2019 decided that the concerned candidate may be called for counselling-cum-Documents verification pursuant to the Hon'ble High Court Order dated 31.12.2018 and vide Order No.109-SSB of 2020 dated 11.03.2020 constituted committee for Document Verification of Candidate on 16th of March 2020 for the post of Jr. Pharmacist (District Cadre Kupwara) in compliance with the directions of the Hon'ble High Court passed in SWP No. 252/2018 and vide Notice No. SSB/Secy/Sel/2020/761-68 dated 06.03.2020 called the petitioner for Document Verification for the post of Jr. Pharmacist (District Cadre Kupwara);and


Whereas, the J&K Services Selection Board vide Communication No. SSB/Secy/Sel/2018/10644-50 dated 22.10.2018 forwarded the Selection List to the Indentment Department wherein it is mentioned at Serial No. 2 under SC Category that one post be kept reserved as per Hon'ble High Court directions of the Hon'ble High Court passed in SWP No 252/2018 titled Surinder Kumar V/s State of J&K; and


Whereas, the Document Verification of the petitioner was conducted on 16/03/2020 for the aforementioned post in compliance to the Hon'ble High Court direction dated 31.12.2018 passed in afore titled writ petition and as per decision of 169th Board meeting held on 06.05.2020 and his documents were accepted by the Document Verification Committee constituted by the J&K Services Selection Board vide Office Order No. 109-SSB of 2020 dated 11.03.2020; and

Whereas, the matter was examined by the J&K Services Selection Board in its 174th meeting held on 16th September, 2020 in compliance to the directions of the Hon'ble High Court, Jammu and as per available records in the office of J&K Services Selection Board and it was decided to recommend the candidature of the candidate namely Surinder Kumar to the Indenting department for the post of Junior Pharmacist, (Health and Medical Education Department) District Cadre Kupwara by way of detailed speaking order. Thereafter, the matter was again re-examined by the Board in its 177th meeting held on 22nd and 23rd of December, 2020 and the Board after reexamining the matter, decided to recommend the candidature of the candidate namely Surinder Kumar to the Indenting Department for appointment to the post of Junior Pharmacist, (Health and Medical Education Department) District Cadre Kupwara, pursuant to the advertisement notification No. 07 of 2015 dated 02.12.2015, Item No.686.

Now, therefore, in deference to Judgment/order dated 31.12.2018 passed by the Hon'ble High Court in SWP No 252/2018 titled Surinder Kumar V/s State of J&K and others and as per the decision of the Board, the petitioner namely **Surinder Kumar S/o Chet Ram R/O Rakh Amb Talli, Tehsil and District Samba**, is hereby recommended to the Indenting Department for appointment against the post of Junior Pharmacist, (Health and Medical Education Department) District Cadre Kupwara under SC Category pursuant to Advertisement Notification No. 07 of 2015 dated 02.12.2015, Item No. 686. The Merit position of the petitioner who will figure at Serial No. 2 under SC Category as per Selection List already forwarded to the Indenting department vide communication No. SSB/Secy/Sel/2018/1064/50 dated 22.10.2018 is enclosed herewith as Annexure-A. However, the terms and conditions will be same as per Selection List forwarded to the Indenting Department vide Communication No. SSB/Secy/Sel/2018/1064/50 dated 22.10.2018.


