**Subject:** O.A No. 61/423/2020 titled Ankush Chib V/s UT of J&K and Others.

Whereas, the Jammu and Kashmir Services Selection Board advertised various posts including the post of Audio Visual Technician/Technician in Audio Visual Aides, Photograph and Artist under Health and Medical Education Department, Divisional Cadre Jammu (GMC Kathua) in pursuant to Advertisement Notification No. 05 of 2019 dated 01.02.2019 under Item No. 25; and

Whereas, the Jammu and Kashmir Services Selection Board after completion of the Selection Process issued the Selection List and the same was forwarded to the Indenting Department (Health and Medical Education Department) vide Communication No. SSB/Secy/Sel/J/27/2020/723-29 dated 20.01.2020 wherein the last selected candidate under OM category secured 69.3800 points and the applicant namely Ankush Chib is 62.71 points under OM Category which is much below the last selected candidates under OM and OM/Wait Category; and


Whereas, the applicant filed an O.A bearing No. 61/423/2020 before the Hon'ble Central Administrative Tribunal at Jammu titled Ankush Chib V/s UT of J&K and ors, and the Hon'ble Tribunal vide its order dated 13.08.2020 disposed of the O.A with the following order:-

"After hearing both the sides, we dispose of the OA with directions to the Respondents to consider the claim of the applicant as projected in the OA under Rules, in light of the judgments rendered by the Apex Court and thereafter if the case of the applicant is recommended, the concerned Respondents shall consider the case of the applicant for appointment in accordance with law and in light the law laid down by the Hon'ble Apex Court. The entire exercise shall be carried by the Respondents within a period of two months from the date of receipt of the certified copy of this order. OA is accordingly disposed of."; and

Whereas, the matter was examined by the Board in its 177<sup>th</sup> meeting held on 22<sup>nd</sup> and 23<sup>rd</sup> of December, 2020 in deference to the order dated 13.08.2020 passed by the Hon'ble Tribunal and the Board after examining the matter found that the claim of the applicant is devoid of any merit owing to the fact that the applicant scored much less marks than the last selected candidate in the written test and accordingly decided to reject the claim of the applicant namely Ankush Chib S/o Madan Singh R/o Village Tohana, Satrayian, Tehsil Suchetgarh, Jammu by passing a speaking order; and

Now, therefore, in deference to order dated 13.08.2020 passed by the Hon'ble Tribunal in OA No. 61/423/2020 titled Ankush Chib V/s UT of J&K and ors and as per the decision of the Board, the petitioner namely Ankush Chib S/o Madan Singh R/o Village Tohana, Satrayian, Tehsil Suchetgarh, Jammu for the post of Audio Visual Technician/Technician in Audio Visual Aides, Photograph and Artist under Health and Medical Education Department Divisional Cadre Jammu (GMC Kathua) in pursuant to Advertisement Notification No. 05 of 2019 dated 01.02.2019, Item No. 25 is found devoid of merit and hereby rejected.
