Whereas, the J&K Services Selection Board (JKSSB) vide Advertisement Notification No. 02 of 2020 dated 06.07.2020 invited application forms for the post of Accounts Assistant (Panchayat) in the Department of Rural Development & Panchayati Raj; and

Whereas, in pursuance to the above said Notification vide Application No. 7504300546, you applied for the post of Accounts Assistant (Panchayat); and

Whereas, on the basis of your application you were provisionally allowed to appear in the OMR based written examination conducted on 10.11.2020 at Examination Centre GHSS, Ukhral District Ramban; and

Whereas, after smooth conduct of examination you have willfully initiated a malicious campaign against the JKSSB by giving an interview to News Channel Daily Taskeen in Social Media (Facebook) alleging therein leakage of paper of Accounts Assistant (Panchayat) in your Examination Centre; and

Whereas, matter has been got verified by the District Observer Ramban who vide letter no. ADCR/Reader/306 dated 13.11.2020 reported that the allegations levelled by you are totally frivolous and baseless and the examination in the said centre has been conducted in the transparent and fair manner; and


Whereas, after examining the report of District Observer Ramban, the JKSSB deemed it expedient to take notice of the allegations levelled by you and decided to initiate necessary action in

the matter. Before initiating necessary action against you, vide notice No. SSB/Secy/321/323 dated 14.01.2021 an opportunity of being heard was provided to you and you were directed to furnish the substantial evidence in support of allegations levelled by you against JKSSB within a period of seven days from the date of issuance of this notice i.e. upto 21.01.2021, either personally or through authorized person at Central Office of JKSSB at Hema Complex, Sector No. 3, Channi Himmat Jammu at 11.a.m but you failed to present yourself and submit any evidence thereof;

In view of the above, through the medium of this notice, you are, given a final opportunity to furnish the substantial evidence in support of your allegation, failing which, you would be barred from appearing in all examinations to be conducted by JKSSB, besides criminal proceedings shall also be initiated against you without any further notice.
