Order No. 07-SSB of 2021
Dated 23.02.2021

Subject:- Submission of Offline Application Forms for petitioners in light of order dated 03.02.2021 passed by the Hon'ble High Court, Srinagar in WP (C) No.137/2021 titled Meghna Koul and another V/s Union of India and others.

Whereas, the J&K Services Selection Board (JKSSB) invited online applications vide Advertisement Notification No. 03 of 2020 dated 01.12.2020 from eligible candidates for participating in the selection process for Divisional/District Cadre Posts of various categories in different departments under PM Special Package for Kashmiri Migrants and Non Migrant Kashmiri Pandits; and

Whereas, the petitioners have filed a writ petition bearing WP (c) No. 137/2021 titled Meghna Koul and another V/s Union of India and others before the Hon'ble High Court, Srinagar and the Hon'ble High Court vide its order dated 03.02.2021 passed the following directions:-

"..... Meanwhile, the respondent No. 04 is directed to entertain the candidature of the petitioners in term of Advertisement Notice No. 03 of 2020 dated 01.12.2020, however, the acceptance of candidature of the petitioners shall be entirely at their own risk and responsibility and provisionally subject to further directions from this court. It is further made clear that the participation of petitioners in the process of selection shall not create any right on them which will be subject to decision by this court and in the event, the respondents are in the process of finalizing the selection, the petitioners' result shall be kept in a sealed cover."

Whereas, the matter was examined by the Board and it has been decided to comply with the aforesaid Court directions by taking offline Application Forms of the petitioners namely;

1. Meghna Koul aged 41 years W/O Kuldeep Raina R/O Manigaam Ganderbal; and
2. Shashi Kumar aged 44years S/O Prithvi Nath Pandita R/O Nillora Litter Pulwama.

Now, therefore, in deference to the aforesaid directions of Hon'ble High Court, the petitioners namely Meghna Koul and Shashi Kumar are directed to submit the application forms for the posts advertised vide Advertisement Notification No. 03 of 2020 dated 01.12.2020 by or before 10.03.2021 in the Divisional Office of Administrative Officer of J&K Services Selection Board Srinagar/Jammu, at their own risk and responsibility and their candidature is provisional and subject to further directions from the Hon'ble High Court, and fulfillment of conditions laid down in relevant recruitment rules.

Other terms and conditions as laid down in the aforesaid Advertisement Notification shall remain unchanged.
