**Subject:- Select list of the candidates for the post of "Telephone Operator" (Agriculture Production Department), Divisional Cadre Kashmir vide item No.310 (01 of 2011 dated 31-01-2011) and item No.252 (03 of 2016 dated 30-06-2016).**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of **"Telephone Operator" (Agriculture Production Department), Divisional Cadre Kashmir vide item No.310 (01 of 2011 dated 31-01-2011) and item No.252 (03 of 2016 dated 30-06-2016)** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/2018/1748-54 dated 17-02-2018 and SSB/Secy/Sel/2018/8983-89 Dated 31-07-2018 for further course of action; and

2) Whereas, vide notification No. 01 of 2011 dated 31-01-2011, under item No.310 one post for telephone operator was advertised by the Board, under OM category (Agriculture & production Department) against the indent No.Agri/Horti/7/09 dated 02-02-2009. After adopting all procedures by the Board, selection list of one candidate along with one waiting list was forwarded to the Indenting Department vide this office letter No. SSB/Secy/Sel/2018/1748-54 dated 17-02-2018 and the recommendations of both the candidates were kept with held and the selection of one candidate namely Rohi wangnoo selection S.No.01/OM was cancelled vide this office order No. 101-SSB of 2020 dated 06-03-2020 and the recommendation of Shabir Ahmed Mir figuring in waiting list at S.No.01 was released vide letter No.SSB/Sel/Sel//296/2018/422-24 dated 18-01-2021;

3) Whereas, after that a communication has been received from the indenting Department vide No.Agri/Coord/ref/Vacancy/2013-I dated 25-


01-2021 in which a clarification has been sought to with regard to the issuance of two selections lists for the same indent No.Agri/Horti/7/09 dated 02-02-2009; and

4) Whereas, from the perusal of the record, it has come to fore that the post has been advertised twice by the Board and due to inadvertently the two selections list have been forwarded to the indenting Department vide this Office letter No. SSB/Secy/Sel/2018/1748-54 dated 17-02-2018 and SSB/Secy/Sel/2018/8983-89 Dated 31-07-2018 respectively against same Indent bearing No.Agri/Horti/7/09 dated 02-02-2009; and

5) Whereas, the case of the selection for the post of **"Telephone Operator" (Agriculture Production Department), Divisional Cadre Kashmir vide item No.310 (01 of 2011 dated 31-01-2011)** was placed in the 182<sup>th</sup> Board meeting and Board decided the selection of the candidates namely Shabir Ahmed Mir shall kept in Abeyance with immediate effect, till a final view is taken in the matter.

Now, therefore, in view of the above position, the withheld selection of the candidate namely **Shabir Ahmad Mir S/O Abdul Aziz Mir figuring at S.No.01/OM/Wait** released vide letter No.SSB/Secy/Sel/296/2018/422-424 dated 18-01-2021 for the post of "Telephone Operator" (Agriculture & Production Department), Divisional Cadre Kashmir vide item No.310 (01 of 2011 dated 31-01-2011) is kept in abeyance with immediate effect, till a final view is taken in the matter.
