
ORDER NO. 215 -SSB of 2021

Subject:- Cancellation of candidature of candidate for the post of "Jr. X-Ray Technician," ( Health and Medical Education Department ) District Cadre Jammu vide Advertisement notice No. 06 of 2013 under item No.464.

Referere Decision of 182<sup>nd</sup> Board meeting of JKSSB.


- 1) Whereas, the J&K Services Selection Board issued final Select List of the candidates for the post of post of "Jr. X-Ray Technician," ( Health and Medical Education Department ) District Cadre Jammu vide Advertisement notice No. 06 of 2013 under item No.464 and recommended the same to the Financial Commissioner to the Government, (Health and Medical Education Department) Civil Secretariat, Jammu vide letter No. SSB/Secy/Sel/2015/3520-26 dated 30-11-2015 for further course of action; and
- 2) Whereas, amongst others, the recommendation of one candidate namely Bhubneshwar Kumar S/O Madan Lal Chargoitra R/O Flora Nagbani, Jammu figuring at S.No. 02 under OM Category for the above said post had been kept withheld for want of certain clarification; and
- 3) Whereas, the said candidate was required to furnish the deficient documents in respect of his candidature within 30 days and he choose not to furnish the same and instead submitted an affidavit duly sworn before a Sub-Judge, Judicial Mobile Magistrate, Jammu on 31<sup>th</sup> October 2020 that he was not interested in joining against the said post; and
- 4) Whereas, despite furnishing of the affidavit, it was deemed expedient to give a Final notice to the candidate through print media and by post. Accordingly, notice vide this office No. SSB/Secy/Sel/55/2015/J/244-247 Dated 11-01-2021,



was served to him, asking therein to furnish the requisite documents within 15 days, failing which his selection against the said post shall be cancelled without further notices; and

5) Whereas, the said candidate again failed to furnish the requisite documents for release of his withheld recommendation for the post under reference and it was presumed that he was not interested in getting appointed against the said post and which warrants cancellation of his, so that waiting list already forwarded to the indenting department, could be operated.

6) Now, therefore, in view of the facts and circumstances narrated herein above, the candidature of the candidate namely **Bhubneshwar Kumar S/O Madan Lal Chargotra R/O Flora Nagbani, Jammu figuring at S.No. 02 under OM Category** for the post of "Jr. X-Ray Technician," (Health and Medical Education Department) District Cadre Jammu vide Advertisement notice No. 06 of 2013 under item No.464 is cancelled/withdrawn ab-initio. The indenting department may operate the waiting list, if required, in accordance with extant rules.
