Subject: SWP No. 1154/2018 titled Ravinder Kumar Vs State of J&K and others.

Whereas, the J&K Services Selection Board advertised various posts including the posts of Jr. Theatre Technician in the Health and Medical Education Department, District Cadre Udhampur in pursuance to Advertisement Notification No. 06 of 2015 dated 01.09.2015 under Item No.651, with the following break up:-SC=01,RBA=01 Total =02;and

Whereas, after completion of the Selection Process, the Selection List of Successful Candidates was issued and forwarded to the Indenting Department Vide endorsement No. SSB/Secy/Sel/2018/3604-11 dated 02.04.2018; and

Whereas, as per merit list prepared by the Board the candidate/petitioner (Ravinder Kumar, who applied under RBA Category) secured 36.3333 points and the selected candidate Ganesh Kumar S/o Om Prakesh who figured in the Selection List under RBA Category secured 37.000 points;and


Whereas, in the meanwhile, the petitioner approached the Hon'ble High Court by way of writ petition bearing SWP No. 1154/2018 titled Ravinder Kumar Vs State of J&K and others and the Hon'ble High Court vide order dated 04.06.2018 disposed of the writ petition with the following directions:-

"...In view of the aforesaid submissions and in the facts of the case, I deem it apposite to dispose of the writ petition with a direction to respondent Nos. 2 and 3 to verify the documents of the petitioner, if there is no legal impediment. The same shall be done expeditiously preferably within a period of one week from the date of receipt of certified copy of this order. With the aforementioned observations, the writ petition is disposed of along with connected MP.";and

Whereas, the matter was examined by the J&K Services Selection Board in its 157th meeting held on 30th September, 2019 in compliance with the directions of the Hon'ble High Court, Jammu and as per available records, it was decided to reject the claim of the petitioner by way of a speaking order.

Now, therefore, the case of the petitioner namely **Ravinder Kumar S/o Sh. Jagan Nath R/o Seerballa, P.O. Seer Manjla, Ramnagar, District Udhampur** for the post of Jr. Theatre Technician in Health and Medical Education Department, District Cadre Udhampur in pursuance with Advertisement Notification No. 06 of 2015 dated 01.09.2015 under Item No.651 and in compliance with directions passed by the Hon'ble High Court, Jammu in SWP No. 1154/2018 titled Ravinder Kumar V/s State of J&K and Others is considered and found devoid of any merit, hence rejected.
