Subject:- **Cancellation of selection of the candidate for the post of "Accounts Assistant" (Finance Department), District Cadre Samba vide item No.711 (07 of 2010) .**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "**Accounts Assistant**" (**Finance Department**), **District Cadre Samba vide item No.711 (07 of 2010)** and recommended the same to the Intending Department vide this Office letter No. SSB/Secy/Sel/2018/1353-59 Dated 01-12-2108 for further course of action; and

4) Whereas, as per the Bonafide certificate of Bachelor of Computer Application and Master of Computer Application the date of admission were August 2005 and August 2008 respectively and Mode of completion as "Distance Mode"; and

05) Whereas, the case of the candidate was placed in the 178th Board meeting and it was decided to cancel the selection of the candidate, after taking into account the parameters laid down in the Govt. order No.252-HE of 2012 Dated 30-05-2012.
