Whereas, the Services Selection Board vide notification No. 01 of 2016 under Item No. 002 (State Cadre) advertised these posts for seeking applications from the eligible candidates; and

Whereas, the Services Selection Board received 1647 application forms and the candidates were called for type test w.e.f 13.09.2017 at NIELIT Srinagar and w.e.f 01.11.2017 at NIELIT Jammu as per criteria for making selections; and


Whereas, the Services Selection Board shortlisted 213 candidates who qualified the type test and were called for interview on 2nd & 3rd of December, 2020, at Central Office, Services Selection Board Jammu and 8th, 9th & 11th of December, 2020 at Central Office Services Selection Board, Rambagh, Srinagar; and

Whereas, 95 candidates appeared in the interview and on the basis of criteria notified for the purpose a select list of 53 candidates was uploaded by the Board in its official website; and

Whereas, the aforementioned 53 candidates appearing in the above referred the select list were to be allotted to the aforesaid 06 departments in order to ensure that

maximum vacancies/ posts are filled subject to terms and conditions of the Advertisement Notification.
