Consequent upon the receipt of requisition from the Agriculture Production Department, vide Indent No.Agril/ Coord/06/2021/363 dated 23.08.2021 & Agri/Coord/25/2020/355 dated 01-10-2020 followed by Agri/Coord/25/2020 dated 09-12-2020, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts, advertised **15 posts** of Driver and **03 posts** of Truck Cleaner, vide Notification No.05 of 2021 dated 22.09.2021 and 07 of 2020 dated 31.12.2020 under following Item Nos, with the breakup of posts as under:

The JKSSB conducted the Driving Test for these posts, which was followed by the Written Examination (OMR based) on 24.12.2023, and, thereafter, on the basis of merit obtained by the candidates, the Document Verification was conducted.

After seeking preferences from the candidates and on the basis of the principle of *Merit-cum-Preference*, the Final Selection List was approved by the Board and subsequently notified vide Notification No.20-Selection of 2024 dated 22.05.2024.

Accordingly, the undersigned is directed to forward herewith the selection list of **15 posts** of "Driver" and **03 posts** of "Truck Cleaner" Agriculture Production Department, Divisional /District Cadre, advertised vide Notification No. 05 of 2021 dated 22.09.2021 &

The above Selection list shall be subject to the outcome of writ petition(s), if any, pending disposal before any competent Court of jurisdiction related to the selection. The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity etc. or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.


During the process of Document Verification, the educational qualification (Minimum/ Maximum) submitted by candidates for the post has been accepted only on the basis of self declaration/ Affidavit produced by them (Copy enclosed). The appointing authority shall satisfy itself on account of this before issuing the appointment order and, if at any stage, it comes to the notice that they are in possession of qualification other than the required for the post and they have willfully submitted wrong information, the necessary action as per rules may be taken, under an intimation to the J&K Services Selection Board".

It is further requested that in case any certificate/document, during the course of verification, turns out to be fake/ fictitious, appropriate criminal proceedings against such candidates may kindly be initiated and the Board may kindly be kept informed.


