Subject:- Cancellation of selection of the candidate for the post of "Science/Maths Teacher" (School Education Department), District Cadre Pulwama vide item No.022 (06 of 2017 dated 28-12-2017).

01. Whereas, the J&K Services Selection Board issued the selection list of the candidate for the post of "Science/Maths Teacher" (School Education Department), District Cadre Pulwama vide item No.022 (06 of 2017 dated 28-12-2017) and recommended the same to the Intending Department vide communications No. SSB/Secy/Sel/22/2019/1624-30 dated 08-03-2019 for further course of action; and
02. Whereas, the selection of the candidates namely **Samina Hamid D/o Ab. Hamid Ahanger figuring at S.No.07/OM-waiting and Ishfaq Ahmad Wani S/o Gh. Ahmad wani figuring at S.No.03/RBA-waiting** were kept withheld subject to clarification from competent authority with regard to relevance of graduation to prescribed qualification; and
03. Whereas, with regard to equivalence of qualification of the candidates were taken up with the University of Kashmir vide this office letter No. SSB/Secy/Sel/Adm/28/2018/909-10 dated 21.01.2020; and
04. Whereas, the case of the candidates were placed in its 178th Board meeting held on 10.01.2021 and it was decided to cancel the selection of the candidates because they do not possess the requisite qualification prescribed by the Indenting Department for the post in the indent/Recruitment Rules.
