**WHEREAS**, The J&K Services Selection Board issued the selection list of the candidate for the post of "Junior Statistical Assistant" Planning and Development Department (Hon'ble Prime Minister's Special Package), item No. 154 (04 of 2017) Divisional Cadre Kashmir for Kashmiri Migrants and recommendation the same to the intending department vide this office letter No. SSB/Secy/ Sel/89/2019/ 3047-53 dated 11.05.2019, for further course of action; and

**WHEREAS**, the selection of the candidates namely **Neetaksi Koul D/o Anil Safaya S No. 07/OM** and **Shivani Bhat D/o Roshan Lal Bhat S No. 03/OM/ Waiting** was kept withheld subject to production of marriage certificate and PRC of husband; and

**WHEREAS**, the candidates despite a lapse of many months did not furnish the requisite documents and was served final notice no SSB/Sel/89/2019/945-50 dated 2-2-2021.

**WHEREAS**, the case of both the candidates was placed in the 182<sup>nd</sup> Board meeting and it was decided to cancel the candidature of the candidates for the post "Junior Statistical Assistant" Planning and Development Department (Hon'ble Prime Minister's Special Package), item No. 154 (04 of 2017) Divisional Cadre Kashmir for Kashmiri Migrants since the candidates had not submitted the requisite documents after serving the final notice as referred to above, and as a sequel thereto, return the post to the concerned Indenting Department.



