Subject:- Cancellation of selection of the candidate for the post of "Jr. Assistant" (School Education Department), District Cadre Jammu in pursuance to Advertisement Notification No. of 02 of 2013 dated 16-02-2013 under items No.226.

1) Whereas, the J&K Services Selection Board issued the selection list of the candidate for the post of "Jr. Assistant" (School Education Department), District Cadre Jammu in pursuance to Advertisement Notification No. of 02 of 2013 dated 16-02-2013 under items No.226 and recommended the same to the Intending Department vide this Office letter No. SSB/Secy/Sel/2017/1466-72 Dated 31-01-2017 for further course of action; and

2) Whereas, the selection of the candidate namely **Maneer Ahmed S/O Mohd Ishaq R/O Gugwal, Pernote District Ramban figuring at S.No.01/RBA** was kept withheld subject to validity of qualification certificate and bonafide certificate thereof and valid category certificate on relevant date; and

3) Whereas, the candidate has submit the Bonafide certificate of Bachelor of Computer Application issued by the Registrar, Guru Jambheshwar University of Science and Technology Hisar, Haryana vide No.DE-4/17-13 dated 30-01-2017. Further, the Board has written a letter to the Registrar, University Grants Commission vide No.SSB/Sel/Verif/28/J/2019/5821 Dated 29-11-2019 regarding clarification/genuineness of Graduation. In response of this office letter a reference has been received from the concerned vide No.F.No.23-13/2019(DEB-11) Dated 25-06-2020, which reveal that the Guru Jambheshwar University, Hisar (Haryana) is a State University and the State Government Universities are not authorized to open study centre/off campus centre beyond the territorial jurisdiction of the State as per the observations of Hon'ble Supreme Court of India in the case of Prof. Yash Pal vs the State of Chhattisgarh (2005). Also these cannot offer their programmes through franchising arrangement with private institutions for the purpose of conducting courses through distance mode or regular mode.; and ;

4) Whereas, the case of the candidate was placed in the 178nd Board meeting and it was decided to cancel the selection of the candidate, for the reason that the said University from which the course has been completed is not authorized to open study center/off campus center beyond its territorial jurisdiction.



Now, therefore, in view of the above position, the withheld selection of **Maneer Ahmed S/O Mohd Ishaq S R/O Gugwal, Pernote District Ramban** figuring at **S.No.01/RBA** for the post of "Jr. Assistant" (School Education Department), District Cadre Jammu in pursuance to Advertisement Notification No. of 02 of 2013 dated 16-02-2013 under items No.226 is hereby CANCELLED abinitio.

1) Whereas, the J&K Services Selection Board issued the Selection List of the candidates for the post of "Jr. Assistant" (PHE/I&FC Department), Divisional Cadre Kashmir under item No.031 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants and recommended the same to the Intending Department vide this Office letter No. SSB/Secy/Sel/M/43/2020/2784-90 dated 28-04-2020 for further course of action; and


2) Whereas, the selection of the candidate namely **Nishu Bali D/O Roshan Lal Bali R/o Kirshama Pattan, District Baramulla, figuring at S.No. 012/OM** was kept withheld subject to validity of graduation degree obtained through Distance Mode in light of Govt. Order No.252-HE of 2012 dated 30-05-2012; and

3) Whereas, the candidate has submitted the Bonafide certificate of Graduation issued by the Director, Department of Open and Distance Learning, I.K. Gujral Punjab Technical University, Kapurthala vide No. IKGPTU/DDE/20759 Dated 05-12-2019 and ;

4) Whereas, as per the Bonafide certificate of Graduation, the date of admission was September 2008 and Mode of receiving education was through Study Centre; and

5) Whereas, the case of the candidate was placed in the 172nd Board meeting and it was decided to cancel the selection of the candidate in light of Govt. order No.252-HE of 2012 Dated 30-05-2012.

Now, therefore, in view of the above position, the withheld selection of **Nishu Bali D/O Roshan Lal Bali R/o Kirshama Pattan, District Baramulla, figuring at S.No. 012/OM** , for the post of "Jr. Assistant" (PHE/I&FC Department), Divisional Cadre Kashmir under item No.031 (04 of 2017 dated 28-11-2017) under Hon'ble Prime Minister's Special Package for Kashmir Migrants is hereby CANCELLED ABINITIO.
