Subject:- **Cancellation of selection of the candidate for the post of "Driver" (Health and Medical Education Department), Divisional Cadre Jammu (GMC Rajouri, Kathua and Doda) vide item No.040 ( 03 of 2019).**


- 1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "**Driver**" (**Health and Medical Education Department**), **Divisional Cadre Jammu (GMC Rajouri, Kathua and Doda) vide item No.040 ( 03 of 2019** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/J/79/2020/3079-85 dated 08-05-2020, SSB/Secy/Sel/J/81/2020/3072-78 dated 08-05-2020 and SSB/Secy/Sel/J/80/2020/3086-92 dated 08-05-2020 respectively for further course of action; and
- 2) Whereas, the candidate namely **Mr. Manjot Singh S/o Amarjeet Singh R/O Chatha, Jammu figuring at S.No. 03, 03/Wait and 05** respectively has been selected and Joined at Government Medical College, Rajouri; and
- 03) Whereas, a complaint was received in this office on 15-01-2021 alleging that the driving license Trans/HGV was issued in favour of the above said candidate on **19-08-2019** i.e after the last date of receipt of application form i.e **14-03-2019**;
- 05) Whereas, the matter was taken up with the Regional Transport Officer, Jammu vide letter No.SSB/Secy/Sel/J/79/2020/488-90 Dated 19-01-2021, with the request to furnish details of driving licence of the above said candidate i.e date of issuance and date of endorsement of HGV/PSV. In response of this office letter, a reference was received from the concerned vide letter No.RTOJ/PA/2021/1351 dated 25-01-2021, where it has been found that the date of endoresemnt of HGV/PSV license is **19-08-2019** and its validity was upto 18-08-2022; and
- 06) Whereas, a notice was issued to the said candidate vide No.SSB/Secy/Sel/J/79/2020/683-86 dated 27-01-2021 with the direction to attend the office of the undersigned within week's time positively from the date of issuance of the notice alongwith all the relevant documents in original including driving license. In response of the said notice, he could not prove that the Transport Vehicle License (HGV/PSV) has been issued in his favour before the cutoff date i.e.**14-03-2019**; and
- 07) Whereas, the matter was deliberated in the Board in its 180<sup>th</sup> Board meeting and after taking note of all releat facts, declared the above said candidate as Not Eligible on the basis of the clarification received from the Regional Transport Officer, Jammu
- 08) Now, therefore, in view of the above position, the selection of candidate namely **Mr. Manjot Singh S/o Amarjeet Singh R/O Chatha, Jammu figuring at S.No. 03, 03/Wait and 05** for the post of "Driver" (Health and Medical Education Department), Divisional Cadre Jammu
