Sub:-Cancellation of candidature of candidates under SRO 202 for the post of "**General Teacher**" (School Education Department), Item No. 010 (06 of 2017) District Cadre Srinagar.

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**General Teacher**" (School Education Department), item No. 010 (06 of 2017) District Cadre Srinagar and recommended the same to School Education Department vide this office letter No. SSB/Secy/Sel/54/1603-09 dated 08.03.2019 for further course of action; and


2/ Whereas, among others, the recommendation in respect of one candidate namely MOHAMMAD ALTAF BUJARD S/O MOLVI MOHD SHAFI BUJARD figuring at S.No.01/ST/Waiting has been kept withheld subject to the clarification with regard to basic eligibility related to Graduation qualification, verification of Graduation and category certificate and production of PG degree from the competent authority; and

3/ Whereas, the said candidate has submitted an undertaking in the shape of affidavit duly attested by Additional Special Mobile Magistrate (Traffic) Srinagar, mentioning therein that the deponent has been selected for the post in question at S.No.01/ST/Waiting and is not interesting to join the said post and neither will claim for the said post in future; and

4/ Whereas, despite of furnishing affidavit, the said candidate was served a notice vide this office No. SSB/Secy/Sel/54/2019/PF/600-603 dated 25.01.2021 asking him to intimate within a period of 07 days in the office of undersigned as to whether he is willing to surrender the said post as per undertaking already furnished by him or otherwise, in case no communication is received from him during the said period, it will be presumed that that the candidate is not willing to join the said post, but the candidate did not respond; and

5/ Whereas, the matter was placed before the Board in its 177th Board meeting wherein it was decided to cancel the candidature of the candidate namely MOHAMMAD ALTAF BUJARD S/O MOLVI MOHD SHAFI BUJARD.

In view of the aforesaid background, the withheld selection of MOHAMMAD ALTAF BUJARD S/O MOLVI MOHD SHAFI BUJARD figuring at S.No.01/ST/Waiting for the post of "General Teacher" (School Education Department), item No. 010 (06 of 2017) District Cadre Srinagar is **cancelled/withdrawn abinitio** and the indenting department is requested to operate the waiting list, if required.
