Sub:- Cancellation of selection of the candidate for the post of "Junior Assistant"(Technical Education/YSS Department) State Cadre vide item No., 002 (01 of 2016).


Whereas, the Jammu & Kashmir Services Selection Board after concluding the selection process notified the selection list of the candidates for the post of Junior Assistant (Department of Youth Services and Sports) State Cadre item No. 002 (01 of 2016) vide No. SSB/Secy/Sel/2020/2707-15 dated 09.03.2021 and forwarded the same to the Indenting Department vide letter No. SSB/Secy/Sel/03/2021/3853-60 dated 20.05.2021, for further course of action; and

Whereas, the recommendation of one candidate namely Vishnu Sharma S/o Balraj Sharma at S.No. 05/ALC was kept withheld for want of requisite documents/clarification with regard to production of Bonafide certificate of Graduation and recognition status of the University issuing BCA; and

Whereas, the candidate produced the Bonafide certificate and accordingly the case was placed before the Board for its consideration in its 186th Board meeting on 26th and 27th of August, 2021 and after threadbare discussion, it was decided to cancel his recommendation in light of Government Order No. 252-HE of 2012 dated 30.05.2012, as mode of completion of course was "Distance Mode" and he has not completed the course in main campus.

Now, therefore, in light of the above facts and discussions of Board in 186th Meeting stated herein above, the recommendation in favour of the candidate namely Vishnu Sharma S/o Balraj Sharma figuring at S.No. 05/ALC for the post of Junior Assistant (Technical/YSS Department) notified vide this office No. SSB/Secy/Sel/2020/2707-15 dated 09.03.2021 and forwarded to the Indenting Department vide No. SSB/Secy/Sel/03/2021/3853-60 dated 20.05.2021 State Cadre advertised vide advertisement No. 01 of 2016, item No. 002 is hereby cancelled ab-initio.
