



Subject:-Cancellation of Select list of the candidates for the post of "Radiography Technician" (Health & Medical Education)(GMC Anantnag) Divisional Cadre Kashmir advertised vide Advertisement Notification No. 01 of 2019, item No.011.

- 1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "Radiography Technician" (Health & Medical Education)(GMC Anantnag) Divisional Cadre Kashmir advertised vide Advertisement Notification No. 01 of 2019, item No.011 and recommended the same to Health & Medical Education Department vide this office letter No. SSB/Sel/Secy/25/K/2020/8490-96 dated 07.12.2021; and
- 2/ Whereas, among others, the recommendation in respect of one candidate namely ISHFAQ AHMAD LONE S/O NAZIR AHMAD LONE figuring at S.No.01 under RBA category has been kept withheld subject to production of valid within date category certificate; and
- 3/ Whereas, the said candidate has submitted two RBA certificates issued by Tehsildar Damhal Hanjipora vide No.973/BAC/DHP/2012-13 dated 19.03.2013 and TDHP/BAC/SC/2019-20/423 dated 26.11.2019. Besides, the candidate has furnished a clarification provided by Tehsildar Damhal Hanjipora vide No.TDHP/MM/2021-22/241 dated 17.12.2021 mentioning therein that the applicant namely Ishfaq Ahmad Lone S/o Nazir Ahmad Lone R/o Boh D H Pora is residing continuously at village Boh and has not migrated from the village till date. The RBA status of the said applicant was not changed between the period 19.03.2013 to 26.11.2019; and
- 4/ Whereas, accordingly the matter was placed before the Board in its 202nd Board meeting held on 13th May, 2022, wherein after extensive discussion on the subject and noting the facts of the case, the Board decided to declare the candidate namely Ishfaq Ahmad Lone as **NOT ELIGIBLE**.

In view of the above mentioned fact and decision of the Board, the candidature of the candidate namely ISHFAQ AHMAD LONE S/O NAZIR AHMAD LONE for the post of "Radiography Technician" (Health & Medical Education)(GMC Anantnag) Divisional Cadre Kashmir advertised vide Advertisement Notification No. 01 of 2019, item No.011 is cancelled/withdrawn abinitio.
