Subject:-Cancellation of Select list of the candidates for the post of "Driver Grade-II" (Transport Department) State Cadre advertised vide Advertisement Notification No. 01 of 2014, item No.013.

1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "Driver Grade-II" (Transport Department) State Cadre advertised vide Advertisement Notification No. 01 of 2014, item No.013 and recommended the same to Transport Department vide this office letter No. SSB/Secy/Sel/2016/12462-68 dated 11.05.2016 for further course of action; and


2/ Whereas, among others, the recommendation in respect of one candidate namely Mohammad Younis Lone S/o Ghulam Mohammad Lone figuring at S.No.03 under Open Merit has been kept withheld subject to production of valid HGV Licence; and

3/ Whereas, the candidate namely Mohammad Younis Lone S/o Ghulam Mohammad Lone figuring at S.No.03 under Open Merit was required to submit HGV Licence within one month after issuance of Selection list, but he candidate failed to provide the same to this office till date; and

4/ Whereas, the said candidate was served final notice vide this office No. SSB/Secy/Sel/02/2016/UT/472-74 dated 18.01.2022 wherein the candidate was asked to submit requisite documents for release of his withheld recommendation for the post of "Driver Grade-II" (Transport Department) State Cadre advertised vide Advertisement Notification No. 01 of 2014, item No.013 in Central Office of JKSSB Hema Complex, Channi Himmat, Sector-03, Jammu and Rambagh, Srinagar within a period of 07 day's from the date of issuance of the notice, however the candidate has failed again submitted the same; and

4/ Whereas, accordingly, the matter was placed before the Board in its 202<sup>nd</sup> Board meeting held on 13<sup>th</sup> May, 2022, wherein it was decided to cancel the candidature of the candidate namely Mohammad Younis Lone S/o Ghulam Mohammad Lone for the post of "Driver Grade-II" (Transport Department) State Cadre advertised vide Advertisement Notification No. 01 of 2014, item No.013.

In view of the above stated facts and decision of the Board, the withheld selection of Mohammad Younis Lone S/o Ghulam Mohammad Lone for the post of "Driver Grade-II" (Transport Department) State Cadre advertised vide Advertisement Notification No. 01 of 2014, item No.013 is cancelled/ withdrawn abinitio.
