ORDER No. 374 -SSB of 2021

Sub:- Cancellation of selection of the candidate for the post of "Jr. ECG Technician/Sr. ECG Technician" (Health and Medical Education Department), pursuant to notification No. 03 of 2016 under item Nos. 234 and 250 respectively.

1/ Whereas, the J&K Services Selection Board notified the selection lists of the candidate for the post of "Jr. ECG Technician/Sr. ECG Technician" (Health and Medical Education Department), pursuant to notification No. 03 of 2016 under item Nos. 234 and 250 respectively and recommended the same to the Intending Department vide this office letter Nos. SSB/Secy/Sel/2018/10410-16 dated 09.10.2018 and SSB/ Secy/Sel/ 2018/10280-86 dated 05.10.2018 respectively for further course of action; and

2/ Whereas, amongst others, the recommendation of one candidate namely Mohd. Rafiq Bhat S/o Ghulam Nabi Bhat figuring at S.No.01 under RBA category was kept withheld subject to production of Bonafide certificate and recognition status of the Institute issuing ECG course certificate; and

3/ Whereas, with regard to recognition status of institute, the matter was taken up with the indenting department vide this office letter No. SSB/ Secy/Sel/259/2018/823 dated 25.01.2019 with the request whether the certificates furnished by the candidate namely Mohd Rafiq Bhat S/o Ghulam Nabi Bhat issued by Bharatiya Institute of Management & Technology, Noida, New Delhi can be considered for the post in question or otherwise; and

4/ Whereas, In response, the indenting department has intimated that Shri Mohd Rafiq Bhat S/o Ghulam Nabi Bhat shall be considered accordingly for the post of Sr/Jr E.C.G Technician as per the merits and in light of observations; and

5/ Whereas, the case was placed before the Board in its 182nd Board meeting wherein it was decided that the instant case shall be forwarded to State Para Medical Council for verification of the validity/recognition status of the concerned Institute. Accordingly the matter was placed before the Board in its 186th Board meeting wherein it was decided that Board noted the facts placed before it and decided that the instant case shall be forwarded to State Para Medical for verification of the validity/recognition status of the concerned Institute; and

6/ Whereas, the matter with regard to recognition status of the Institute and validity of Diploma was taken up with the Registrar, J&K Para-Medical Council, Srinagar/Jammu vide this office letter No. SSB/Sel/Verif/259/ K/18/4426 dated 12.06.2021 with the request to kindly furnish the recognition status of institute viz Bharatiya Institute of Management & Technology, Noida, New Delhi is recognized or otherwise.

7/ Whereas, in response, the Registrar J&K Paramedical Council GMC, Jammu vide No. JKPMC/19-20/63/6556 dated 10.07.2021 has intimated that the Bharatiya Institute




of Management & Technology, Noida, New Delhi does not bear the address of the institute. As such the document verification process could not be undertaken.

8/ Whereas, the case was placed before the Board in its 188th Board meeting for deliberation/decision in light of order No.122-JK(HME) of 2020 dated 04.02.2020 issued by Health and Medical Education Department with regard to recognition status of the institutions located outside of UT of J&K.

9/ Whereas, the Board after noting the facts placed before it and considered the comments received from J&K Paramedical Council, GMC, Jammu Vide no. JKPMC/19-20/63/6556 dated 10.07.2021 together with the recommendation of the sub Committee and decided to declare the candidate namely Mohd Rafiq S/o S/o Ghulam Nabi Bhat as Not Eligible

Now, therefore, in view of the above position, the withheld selection of the candidate namely Mohd Rafiq S/o Ghulam Nabi Bhat figuring at S.No.01 under RBA category for the post of "Jr. ECG Technician/Sr. ECG Technician" (Health and Medical Education Department), pursuant to notification No. 03 of 2016 under item Nos. 234 and 250 respectively is hereby cancelled and the indenting department is requested to operate the waiting list, if required.
