**Subject: Cancellation of candidature and Debarment of candidate namely  
Danish Siraj Diyu  
Order No.112 -SSB of 2024  
Dated: 07 .03.2024**

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) conducted OMR based Examination for the post of Accounts Assistant (Finance) advertised vide Notification 04 of 2020 dated 20.12.2020 on 28.01.2024; and

Whereas, a candidate namely Danish Siraj Diyu S/O Siraj Uddin Diyu R/O 57 Chana Mohalla Chattabal Srinagar appeared in the said examination under Roll No. 20010452 at University of Kashmir Hazratbal Srinagar; and

Whereas, the said candidate was found in possession of mobile phone and using it during the course of examination, as reported by concerned Centre Superintendent, Deputy Superintendent and Centre Observer; and

Whereas, Ms. Ayeena Manzoor D/O Manzoor Ahmad Mir R/O Gundpora Rampora Bandipora had been allowed by the Centre Superintendent as a Scribe for the above mentioned candidate; and

Whereas, vide No. JKSSB-COE0Exam(UT)/101/2023-03 dated 19.02.2024, a show cause notice was issued to the candidate to explain his position. The reply to the said show cause notice was submitted by him on 26.02.2024 and was examined in the light of relevant Rules/Regulations; and

Whereas, the case was placed before the Unfair Means Committee constituted in terms of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022 under part XXX (67), and the committee, after considering the nature of the offence and evidence brought on record, recommended as under:-

***" The candidate has been found in possession of mobile phone; and using it during the conduct of examination for the post of Accounts Assistant (Finance) at University of Kashmir, Hazratbal, Srinagar (Examination Centre), held on 28-01-2024, as reported by the Centre Observer and Centre Superintendent***

***The reports of the Centre Observer, Centre Superintendent, Show Cause notice issued by the Controller of Examinations, JKSSB, and the reply thereof submitted by the candidate, have been examined.***

***The committee observed that the candidate has committed offence under section 64 (b) of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022. Therefore, the committee recommends cancellation of the candidature for the said post, besides debarment for a***



***period of 03 years for all examinations conducted by JKSSB with effect from date of incident."***

Whereas, the recommendations of the committee were placed before the 264<sup>th</sup> Board Meeting held on 06.03.2024, which accepted the recommendations of the Unfair Means Committee.

Therefore, in view of the above and as per section 69 of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, the candidature of candidate namely Danish Siraj Diyu S/O Siraj Uddin Diyu R/O 57 Chana Mohalla Chattabal Srinagar, for the post of Accounts Assistant (Finance) advertised vide Notification 04 of 2020 dated 20.12.2020, is hereby cancelled. The candidate is further debarred from appearing in all the examinations to be conducted by the Board for a period of three (03) years from the date of the incident.
