Subject:- Selection list of candidates for the post of "Sub-Inspector Commercial Taxes" State Taxes Department (Finance Department) Divisional Cadre, Kashmir in respect of advertisement vide Notification No. 03 of 2020 dated 01-12-2020 item No.021, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits.

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "Sub-Inspector Commercial Taxes" State Taxes Department (Finance Department) Divisional Cadre, Kashmir in respect of advertisement vide Notification No. 03 of 2020 dated 01-12-2020 item No.021, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/M/02/2021/6307-13 Dated 23-09-2021 for further course of action; and

2) Whereas, the selection of the candidate namely **Sageer Sameer S/O Ravinder Sharma R/O 149 Purshyar Habba Kadal Srinagar, figuring at S.No. 92/OM** was kept withheld subject to verification of genuineness of Migrant certificate from DMRRR; and

3) Whereas, the candidate has submitted the registration certificate vide No.JK202012004325/1034 Dated 29-12-2020 issued by the Relief and Rehabilitation Commission, Jammu;and


4) Whereas, the Board has been written a letter to the Relief and Rehabilitation Commissioner(M) Jammu vide No.SSB/Sel/Verif/02/Mig/21/3909 Dated 13-04-2022 regarding whether the said candidate is registered with relief and Rehabilitation organization J&K in term of SRO 412 dated 30-12-2009 or otherwise. In response of this office letter a communication has been received from the concerned vide No.RRCM/Verif/22-23/71 Dated 28-04-2022,

which reveals that the applicant is not a registered migrant in terms of SRO-412 with this organization. However, the applicant is registered under SO-52 for seeking Domicile certificate only; and

5) Whereas, the case of the candidate was placed in the 203rd Board meeting and it was decided to cancel the selection of the candidate namely Sagar Sameer, as the candidate is not registered Migrant in terms of SRO-412 dated 30-12-2009.

Now, therefore, in view of the above position, the withheld selection of **Sageer Sameer S/O Ravinder Sharma R/O 149 Purshyar Habba Kadal Srinagar, figuring at S.No. 92/OM** for the post of "Sub-Inspector Commercial Taxes" State Taxes Department (Finance Department) Divisional Cadre, Kashmir in respect of advertisement vide Notification No. 03 of 2020 dated 01-12-2020 item No.021, under Hon'ble Prime Minister Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits is hereby **CANCELLED ABINITIO**. The indenting department may operate the waiting list, if required, in accordance with extant rules.
