Subject:- Select list of Candidates for the post of "Technical Assistant/Technician (Anaes)"(Health and Medical Education Department)' (GMC Baramulla) Divisional Cadre Kashmir, advertisement vide Notification No.02 of 2019/014.

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of "Technical Assistant/Technician(Anaes)"(Health and Medical Education Department)' (GMC Baramulla) Divisional Cadre Kashmir, advertisement vide Notification No.02 of 2019/014 and recommended the same to the intending Department vide this Office letter No. SSB/Sel/Secy/26/K/8429-35 Dated 06-12-2021 for further course of action; and

2) Whereas, among others, the recommendation in respect of one candidate namely IKHAQ AHMAD DAR S/O NAZIR AHMAD DAR figuring at S.No.03/OM has been kept withheld for want of clarification with regard to recognition of SIAS institute from SMF; and

3) Whereas, the candidate has submitted an undertaking in the shape of affidavit duly attested by Judicial Magistrate, Ist Class Anantnag mentioning therein that the deponent has been selected for the post in question at S.NO.03 under open merit and is not interesting to join the said post and neither will claim for the said post; and

4) Whereas, despite of furnishing affidavit, the said candidate was served a notice vide this office No.SSB/Secy/Sel/26/21/K/4187-90/22 dated 02-05-2022 asking him to intimate within a period of 07 days in the office of undersigned as to whether he is willing to surrender the said post as per undertaking already furnished by him or otherwise, it was further provided that in case no communication is received from him during the said period, it will be presumed that the candidate is not willing to join the said post; but the candidate did not respond; and
