**Subject: Final Selection List of the candidates for the post of Works Supervisor in the Public Works (R&B) Department, advertised vide Notification No. 05 of 2020 dated 24.12.2020, under Item Nos. 134- Cancellation of withheld recommendation thereof.**

Whereas, the J&K Services Selection Board (JKSSB), advertised 76 posts of **Works Supervisor**, vide Notification No. 05 of 2020 dated 24.12.2020, under Item No. 134, and subsequently notified the final Selection List for these posts in the Public Works (R&B) Department; and

Whereas, among others, the recommendations of the following candidates were kept withheld on account of deficiencies as indicated against each, with the advice to submit the requisite documents/certificates within a period of one month:

The Institute (AICPE) is based in Maharashtra but the <b>Study Centre</b> from which the candidate has completed his course is located in Kulgam. Hence, the case is being Rejected.

Whereas, the Board vide No. JKSSB-Scry/5/2023-01 (E-7240477) Dated 11.03.2024 issued a Final Notice to these candidates to submit their requisite documents/certificates within a period of Twenty-One (21) days positively from the date of issuance of Final Notice. Whereas, none of them have produced the requisite valid document (s)/certificate(s) till date.

The matter related to withheld cases for the post of Works Supervisor stand discussed at length in various Board meetings viz., 285th Board meeting held on 15.10.2024 and in 286th Board Meeting held on 18.10.2024, wherein, among other cases, the cases of aforementioned candidates were also discussed.

Therefore, in view of the fact that the aforementioned candidates failed to submit the requisite valid documents even after the publication of Final notice and subsequent lapse of considerable time, the withheld recommendations of Mr. Irfan Aaqib, 16-OM Category, Mr. Bilal Ahmad Sheikh, 18-OM/RBA Category, Mr. Aadil Amin Rather, 25-OM Category and Mr. Shahnawaz Ahmad Lone, 27/OM Category for the posts of Works Supervisor, Public Works (R&B) Department, advertised vide Notification No. 05 of 2020 dated 24.12.2020, under Item Nos. 134- are hereby cancelled ab-initio.
