Subject: Cancellation of withheld recommendation of **Sahil Mattoo** S/o Kamal Mattoo, R/o 381/241, Jammu for the post of "**Depot Assistant**" (Food, Civil Supplies & Consumer Affairs Department), District Cadres, (Kashmir Division), advertised vide Advertisement Notification No. 03 2020 dated 01.12.2020, Item Nos. 26 to 35, under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits.


Whereas, the J&K Services Selection Board notified the Final Select list of District Cadre Posts of "**Depot Assistant**" (Food, Civil Supplies & Consumer Affairs Department), District Cadres; (Kashmir Division), advertised vide Advertisement Notification No. 03 of 2020 dated 01.12.2020, Item Nos. 26 to 35, under the Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits and forwarded the same to the Intending Department vide this Office letter No. SSB/Secy/Sel/2021/7046-53 dated 14.10.2021, for further course of action; and

Whereas, among others, the recommendation of **Sahil Mattoo** figuring at Sel. Sr. No. 166/OM was kept withheld subject to production of Matric Date of Birth Certificate; and

Whereas, a Notice was served to the candidate vide No. SSB/Secy/Sel/2021/M/D/2299-2300 Dated: 06.03.2022 which was followed by Final Notice vide No. SSB/Secy/Sel/M/CI/Co/D/4851-52 Dated: 21.06.2022 with the directions to submit the requisite documents in the Central Office of JKSSB, Hema Complex, Channi Himmat, Sector -03, Jammu. Despite lapse of considerable time, the candidate had not submitted the requisite documents.

Whereas, the above case was placed in the 290th Board Meeting which decided to cancel his withheld recommendation on account of non-submission of requisite documents; and

Now therefore, the withheld recommendation of **Sahil Mattoo**, figuring at Sel.
