**Subject:** Cancellation of withheld recommendations of candidates for the Post of Sub-Inspector (Finance Department) Divisional Cadre, Kashmir, Advertised vide (Advertisement Notification No. 03 of 2020 dated 01.12.2020, Item No. 021, under Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits.

The J&K Services Selection Board issued the Final Selection List of the candidates for the post of Sub-Inspector (Finance Department) Divisional Cadre, Kashmir, vide (Advertisement Notification No. 03 of 2020 dated 01.12.2020, Item No. 021, under PM Package and recommended the same to the Indenting Department vide No. SSB/Sel/Secy/M/02/2021/6307-13 dated 23.09.2021 for further course of action.

However, the recommendations of (09) candidates annexed at **Annexure "A"** were kept withheld for want of certain clarification with regard to their documents.

Accordingly, the Notice was served to these vide No.SSB-SD/2/2023-03 (E-7101811) dated 22.11.2023 which was followed by Final Notice vide No.JKSSB-SD/2/2023-03 (E-7101811) dated 29.01.2024 with the directions to submit the requisite documents in the Central Office, JKSSB, CPO Chowk, Panjtirthi. Despite lapse of considerable time, the candidates have not submitted the requisite documents. These cases were placed in the 290<sup>th</sup> Board Meeting, wherein it was decided to cancel their withheld recommendations on account of their failure to fulfil the deficiencies.

Now, therefore, the withheld recommendations of the candidates as contained in **Annexure "A"** to this Notification for the Post of Sub-Inspector, Commercial Taxes (Finance Department) Divisional Cadre, Kashmir, vide (Advertisement Notification No.03 of 2020) dated 01.12.2020, Item No. 021, under PM Package, are hereby **CANCELLED**.
