NOTIFICATION

Subject: Selection List for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021 – Cancellation of withheld recommendation thereof.

Whereas, the J&K Services Selection Board (JKSSB), vide Notification No. 01-Selection of 2024 dated 8th of January, 2024, issued under endorsement No. JKSSB-Scry/26/2023-03(E-7376857), notified the Final Selection List for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021 and forwarded the recommendation of the selected candidates to the Home Department vide communication No. JKSSB-Scry/26/2023-03(E- 7376857) dated 10.01.2024; and

Whereas, vide notification dated 27.07.2024 the Revised Selection List of the candidates selected under EWS category was notified and among the selectees, the recommendation of candidates namely Mr. Vishav Pratap Singh, S/o Chain Singh, R/o 86, Sair, Kalakote, Rajouri, Jammu, 185202, figuring at Sr. No. 109/EWS category and Mr. Parveen Kumar, S/o Sudesh Kumar, R/o 2, Ward no. 2, Kella, Udampur, Ramnagar, Jammu, 182122, figuring at Sr. No. 119/EWS category were kept withheld subject to production of valid within date EWS certificate; and

Whereas, the J&K Services Selection Board served a notice dated 02.08.2024 to the above-mentioned candidates to submit the pending/requisite documents/certificates as indicated against their names; and

Whereas, this was followed by Final Notice issued vide No. JKSSB/Scry/26/2023-03(E-7376857) dated 09.09.2024 advising the above mentioned candidates to submit the requisite document within a period of 07 days; and


Whereas, the mentioned candidates failed to produce the requisite valid within cut-off date EWS certificates and accordingly the withheld recommendation cases were placed in the 295th Board Meeting, which taking note of the fact that despite sufficient time/opportunities afforded to the candidates namely Mr. Vishav Pratap Singh and Mr. Parveen Kumar, the candidates have failed to produce the requisite document (valid within cut-off date EWS certificate) and, accordingly decided to cancel their withheld recommendation.

Now, therefore the withheld recommendation of the candidates namely Mr. Vishav Pratap Singh, S/o Chain Singh, R/o 86, Sair, Kalakote, Rajouri, Jammu, 185202, figuring at Sr. No. 109/EWS category and Mr. Parveen Kumar, S/o Sudesh Kumar, R/o 2, Ward no. 2, Kella, Udampur, Ramnagar, Jammu, 182122, figuring at Sr. No. 119/EWS category for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021, are hereby cancelled.
