Whereas, the J&K Services Selection Board (JKSSB), advertised these 76 posts of Works Supervisor, vide Notification No. 05 of 2020 dated 24.12.2020, under Item No. 134, notified the final Selection List for the posts of Works Supervisor in the Public Works (R&B) Department; and

Whereas, among others, the recommendations of following candidates were kept withheld on account of deficiencies as indicated against each, with the advice to submit the requisite documents/certificates within a period of one month:

Whereas, the Board vide No. JKSSB-Scry/5/2023-01 (E-7240477) Dated 11.03.2024 issued a Final Notice to these candidates to submit their requisite documents/certificates within a period of Twenty-One (21) days positively from the date of issuance of Final Notice. Whereas, none of them have produced the requisite document/certificate till date.

The matter related to withheld cases for the post of Work Supervisor stand discussed at length in various Board meetings viz., 285th Board meeting held on 15.10.2024



and in 286th Board Meeting held on 18.10.2024, wherein, among other cases, the cases of aforementioned candidates was also discussed. Therefore in view of the fact that the aforementioned candidates failed to submit the requisite documents even after the publication of Final notice and subsequent lapse of considerable time, the withheld recommendations of Mr. Mohammad Irfan Dar, 07-OM/RBA Category, Mr Mudesir Nazir, 09-OM/Social Caste Category, Mr Ubaid Bashir 15-OM/Social Caste Category and Mr. Vikrant Sharma 03-EWS Category for the posts of Works Supervisor, Public Works (R&B) Department, advertised vide Notification No. 05 of 2020 dated 24.12.2020, under Item Nos. 134- are hereby cancelled ab-initio.
