NOTIFICATION

Subject: Selection List for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021 – Cancellation of withheld recommendation thereof.

Whereas, the J&K Services Selection Board (JKSSB), vide Notification No. 01-Selection of 2024 dated 8th of January, 2024, issued under endorsement No. JKSSB-Scry/26/2023-03(E-7376857), notified the Final Selection List for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021 and forwarded the recommendation of the selected candidates to the Home Department vide communication No. JKSSB-Scry/26/2023-03(E- 7376857) dated 10.01.2024; and

Whereas, vide notification dated 27.07.2024 the Revised Selection List of the candidates selected under EWS category was notified and among the selectees, the recommendation of candidate namely **Mr. Sushil Kumar**, S/o Kamal Dass R/o Nikkian Marchangi, Akhnoor, Jammu, 181203, **figuring at Sr. No. 110/EWS category** was kept withheld subject to production of valid within date EWS certificate. Also, the wait list for the post mentioned was issued on 30.07.2024 under endorsement No. JKSSB-Scry/26/2023-03(E-7376857) dated 30.07.2025 and the recommendation of candidate namely **Mr. Ashok Kumar Singh**, S/o Punjab Singh, R/o 60, 2, Ghari, Jammu, Ramban, Rajgarh, Ghari, 182148, **figuring at Sr. No. 02/EWS category in the wait list** was kept withheld subject to production of valid within date EWS certificate ; and


Whereas, the J&K Services Selection Board served a notice dated 02.08.2024 to the above-mentioned candidates to submit the pending/requisite documents/certificates as indicated against their names; and

Whereas, this was followed by Final Notice issued vide No. JKSSB/Scry/26/2023-03(E-7376857) dated 09.09.2024 advising the above mentioned candidates to submit the requisite document within a period of 07 days; and


Whereas, the mentioned candidates failed to produce the requisite valid within cut-off date EWS certificates and accordingly the withheld recommendation cases were placed in the 302nd Board Meeting, in which the Board took note of the fact that despite sufficient time/opportunities afforded to two candidates namely Mr. Sushil Kumar and Mr. Ashok Kumar Singh, the candidates have failed to produce the requisite document(s) (valid within cut-off date EWS certificate) and, accordingly decided to cancel their withheld recommendation.

Now, therefore the withheld recommendation of two candidates namely Mr. Sushil Kumar, S/o Kamal Dass R/o Nikkian Marchangi, Akhnoor, Jammu, 181203, figuring at Sr. No. 110/EWS category in the revised selection list for EWS category and Mr. Ashok Kumar Singh, S/o Punjab Singh, R/o 60, 2, Ghari, Jammu, Ramban, Rajgarh, Ghari, 182148, figuring at Sr. No. 02/EWS category in the wait list for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021, are hereby cancelled.
