Subject: O.A./162/2023 titled Parvaiz Ahmad Bhat Vs UT of Jammu and Kashmir and Ors – Recommendation in favour of Mr. Mohmad Arif Sheikh for the post of "Basic Health Worker" Divisional Cadre Kashmir, Item No. 244, under Open Category, advertised vide Advertisement Notification 02 of 2021 dated 26.03.2021.

Sir,

Kindly refer to this office communication No. JKSSB/Sel/Secy/502-07 dated 17.04.2023, wherein it was requested to keep one post in the Open Merit, under Item No. 244, for the post of "Basic Health Worker", Divisional Cadre Kashmir, advertised vide Notification 02 of 2021 dated 26.03.2021, reserved, against which the candidature of Mr. Mohmad Arif Sheikh S/o Abdul Rashid Sheikh, was otherwise figuring. This was done, as a measure of abundant caution, pending disposal of O.A./162/2023 titled Parvaiz Ahmad Bhat Vs UT of Jammu and Kashmir and Ors.

Also, vide letter No. JKSSB/Sel/Secy/2023/532-37 dated 21.06.2023, a clarification was sought from the Indenting department regarding the recognition status of the Institute and the equivalence of Course possessed by the petitioner with the qualification prescribed as per indent. Vide communication no. ME-leg/143/2023-01 dated 21.09.2023, the Health and Medical Education Department forwarded the clarification from J&K Para Medical/Nursing Council (Principal GMC, Srinagar), bearing communication No. SPMC/GMC/SGR/3655-57 dated 18.06.2023, as a result of which the petitioner namely Parvaiz Ahmad Bhat is rendered in-eligible and it paves way for the appointment of Mr. Mohmad Arif Sheikh, S/o Abdul Rashid Sheikh to the instant post.

The matter was accordingly, deliberated in the Board in light of the clarification received from the Indenting Department and it has been decided by the Board to operate upon the recommendation made in favour of Mr. Mohmad Arif Sheikh.

Accordingly, in view of the factual position stated above, I am directed to convey the above decision of the Board and to request you to operate upon the recommendation made in favour of **Mr. Mohmad Arif Sheikh S/o Abdul Rashid Sheikh** for the post of "**Basic Health Worker**" Divisional Cadre Kashmir, Item No. 244, under OM, advertised vide Notification **02 of 2021 dated 26.03.2021**, as already conveyed vide forwarding letter no. **JKSSB/Sel/Secy/2022-23/362-66 dated 28.02.2023**. 
