Subject: O.A .No.61/1351/2022 titled Deepak Sharma Vs UT of J&K and other. Disposal of representation thereof.

Whereas, the Jammu and Kashmir Services Selection Board advertised various posts of Accounts Assistant (Panchayat) in Department of Rural Development and Panchayat Raj, District Cadre vide Advertisement Notification No. 02 of 2020 dated 06.07.2020; and

Whereas, the Jammu and Kashmir Services Selection Board after completion of the selection process, issued the Selection List and forwarded the same to the Indenting Department ;and

Whereas, as per the *merit cum preference* criteria, the applicant Mr. Deepak Sharma figured in the waiting list at serial no.7 under PSP category and was accordingly recommended for appointment in District Cadre Kulgam upon operationalization of the said waiting list; and

Whereas, the applicant filed the O.A. before the Hon'ble Central Administrative Tribunal, Jammu seeking a direction to change the allocated District of the applicant from District Kulgam to District Kathua on account of non-joining of some candidate in PSP Category in District Kathua for the post of Account Assistant (Panchayat); and

Whereas, the Hon'ble Tribunal disposed of the O.A on 26.09.2022 with the following directions:-

" I have considered the submissions made by the Ld. Counsels for both the sides and perused the material on record. Without expressing any opinion on the merits of the case, the O.A. is disposed of at Admission stage with direction to respondents to treat a copy of this O.A. as representation of the applicant and decide it, as per relevant rules, regulations and instructions on the subject, by passing a reasoned and speaking order within a period of four weeks from the date of receipt of a certified copy of this order. A copy of speaking order be communicated to the applicant within one week thereafter. 8. With the above direction, the O.A. stands disposed of. No costs"

Whereas, the case of the applicant has been examined in the Board with the relevant record and rules prevailing in the field for allocation of cadre, it was found that the selection of the applicant has been made strictly as per merit cum preference and the selection process

w

has been concluded and the Selection Lists has been forwarded to the Indenting Department, consequent upon which the Board has become office functus after forwarding of the Selection list. Further the applicant has also joined against the allotted cadre in pursuance to his final Selection and the Board has no further role in the matter.

Now, therefore, in deference to the Order dated-26.09.2022 passed by the Hon'ble Tribunal the case of the applicant has been considered and found devoid of any merit, hence rejected.
