Whereas, the Jammu and Kashmir Services Selection Board advertised various posts including the post of Dhobi, District Cadre Jammu vide Advertisement Notification No. 02 of 2021 dated- 26.03.2021;

Whereas, the Jammu and Kashmir Services Selection Board issued the list of the candidates falling under consideration zone for various posts of Health and Medical Education Department advertised vide Notification No. 02 of 2021 dated: 26-03-2021 for which the Computer Based Test (CBT) was conducted w.e.f. 17th August, 2021 to 25th August 2021; and

Whereas, the candidates figuring in the consideration zone were called to appear for Document Verification before the designated Document Verification Committees in Jammu and Srinagar offices of Services Selection Board, J&K; and

Whereas, the applicant filed O.A. before the Hon'ble Central Administrative Tribunal, Jammu for one more opportunity for document verification for the aforesaid post, as he could not appear on scheduled date due to various reasons. Whereas, the Hon'ble Tribunal vide it's order dated-17.12.2022 passed the following directions:-

"In the meanwhile, the respondents are directed to consider and take a decision on the representation of the applicant dated 28.11.2022 on humanitarian grounds."

Whereas, the case of the applicant has been considered by the Board in compliance to the directions dated- 17.12.2022 passed by the Hon'ble CAT Jammu and as per records available, it was found that allowing the applicant for document verification at this stage is not permissible since the two opportunities to participate in the Document Verification to all the eligible candidates has already been given ie.first on 18th and second on 19th of Oct. 2022 and the left over candidates were again given an opportunity on 04.11.2022; and
