Consequent upon the receipt of indent/requisition from the Labour & Employment Department, vide Indent No. L&E/Gen/53/2019-I dated 30-09-2020, followed by L&E/Gen/53/2019-I dated 04-12-2020, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts, advertised **05 posts** of Driver, vide Notification No. 04 of 2020 dated 16.12.2020, under Item Nos. 070 &077, with the following breakup:

The JKSSB conducted the Computer Based Test (CBT) for these posts and, thereafter, on the basis of merit obtained by the candidates, the Document Verification was conducted.


During the process of Document Verification, the educational qualification (Minimum and Maximum) submitted by candidates for the post has been accepted only on the basis of self declaration/ Affidavit produced by them (copy enclosed). The appointing authority shall satisfy itself on account of this before issuing the appointment order and, if at any stage, it comes to the notice that they are in possession of qualification other than the required for the post and they have willfully submitted wrong information, the necessary action as per rules may be taken, under an intimation to the J&K Services Selection Board.

It is further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, appropriate criminal proceedings against such candidates may kindly be initiated and the Board may kindly be kept informed.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation are released by the Selection Agency shall submit their verification rolls in triplicate before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.


