The J&K Services Selection Board, vide letter No.SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022, forwarded the Final Selection List/Allocation of Cadres to the General Administration Department for 3422 Class-IV posts, under the provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020, advertised vide Notification No. 01 of 2020 dated 26.06.2020.

In the aforesaid Selection List, among others, the recommendation of various candidates, selected under ESM (Ex- Servicemen) category, was kept withheld subject to *clarification regarding maximum qualification*.

The Jammu and Kashmir Ex-servicemen (Re-employment in Public Services and Posts) Rules, 2021, notified vide S.O. 361 of 2021 dated 20.10.2021, contain the following provisions regarding educational qualification of ESM candidates seeking employment against civil posts:

"Special Provision Regarding Educational Qualification.-(1) For appointment to any reserved vacancy, a matriculate ex-serviceman (which term includes an exserviceman, who has obtained the Indian Army Special Certificate of Education or the corresponding certificate in the Navy or Air Force); who has put in not less than 15 years of service in the armed Force may be considered eligible for appointment to the posts for which the essential educational qualification prescribed is graduation..."

However, despite the lapse of considerable time, the candidates, as figuring in per Annexure-A have failed to provide sufficient documentary proof in support of their withheld recommendations.

Accordingly, through the medium of this Notice, the candidates as figuring in **Annexure-A**, are hereby given the last opportunity to furnish requisite documents/affidavit in original regarding their maximum qualification, possessed by them on academic or honorary basis, within a period of **21 days** from the date of issuance of this Notice in the J&K Services Selection Board, CPO Chowk Panjirthirti, Jammu/Zum Zum Building Rambagh, Srinagar (as per convenience), failing which all such candidates shall forfeit their right of being recommended for these Class-IV posts, advertised vide Notification No. 01 of 2020 dated 26.06.2020 and, accordingly, their withheld recommendations shall be cancelled forthwith.
