Final Selection List/Allocation of Cadres in respect of the posts earmarked for Physically Challenged Candidates (Sub-category of Deaf & Hard of Hearing)- advertised vide Notification No. 01 of 2020 dated 26.06.2020.

NOTIFICATION

Whereas, the General Administration Department, vide No. GAD/Mtg/RB-IV/50/2020 dated 22.06.2020, forwarded the requisition for filling up 8575 Class-IV posts, pertaining to various departments under direct recruitment, in accordance with the provisions of the Jammu and Kashmir Appointment to Class IV (Special Recruitment) Rules, 2020, notified vide S.O. 184 of 2020 dated 04.06.2020; and

Whereas, the aforesaid Class-IV posts, belonging to various departments, were advertised by the Board vide Notification No. 01 of 2020 dated 26.06.2020 and the OMR based Objective Type Written Examination was held in three batches on 27th, 28th February and 1st March, 2021; and

Whereas, some Persons with Disabilities (PwDs), belonging to the subcategory of Deaf & Hard of Hearing, approached the Hon'ble Central Administrative Tribunal, Srinagar through the medium of O.A No. 1764/2021 titled Peer Mohammad Arif Vs Social Welfare & Ors, with the prayer that the Board has not applied Horizontal Reservation to the PwD candidates. Pertinently, the Horizontal Reservation for these posts could not be applied initially for want of pending clarification from the General Administration Department as the post of Orderly/Class-IV was mentioned at two entries in the Government Order No. 59 of 2021 dated 15.04.2021. However, while filling up posts in Phase-I, 320 posts were kept reserved to the PwDs till further clarification; and

Whereas, the Hon'ble CAT, while hearing the matter, passed the following interim directions:

"In the meantime, the respondent shall not finalize the select list with regard to the deaf and hard of hearing category as per Govt. order dated 05.04.2021 till next date of hearing."

Whereas, the selection for the aforementioned posts was finalized by the
Board in two phases including for the Persons with Disabilities after clarification from the

GAD/amendments in the extant regulations, except for the 80 posts earmarked to the Deaf and Hard of Hearing Category on account of the aforementioned directions of the Hon'ble CAT, while as 240 posts allocable to other three sub-categories of the PwDs were filled up; and

Whereas, the Hon'ble Central Administrative Tribunal, while hearing the matter again on 03.11.2022, directed as under:

"Learned counsel for the respondents are directed to place on record the result of 13 applicants on the next date to show whether they have secured sufficient marks or they have been selected or not. Respondents are at liberty to proceed with further selection and appointment in this regard except for 13 applicants. Respondents are granted 3 weeks' time to do the needful."

Whereas, the above information was submitted in the Hon'ble CAT and after considering the details as made available, the Hon'ble CAT, Srinagar disposed of the matter, vide its Order dated 06.12.2022, with the following directions:

"...This MA is disposed with direction to the respondent to complete the process of selection and appointment as per rules. Those candidates who have met the score of written examination in sufficient numbers. MA is disposed off..."

Whereas, the matter was examined and placed in the Board for consideration. The Board, in its 216th Meeting held on 26.12.2022, decided to fill these 80 posts kept reserved for the candidates belonging to the category of Deaf and Hard of Hearing; and

Whereas, the JKSSB, accordingly, notified the Provisional Selection List for the 80 posts of Class-IV, belonging to the Deaf and Hard of Hearing Category, which were kept reserved/unfilled on account of the Court directions, vide notification No. JKSSB/55/2022-05 dated 03.01.2023, giving candidates 03 days' time to represent with any grievance/objection through official email address i.e.class4hearing2022@gmail.com; and

Whereas, an original application before the Central Administrative Tribunal at Srinagar titled Mehak Ali Makroo Vs General Administration Department, in O.A No. 39/2023 was filed, in which the Hon'ble CAT passed an interim direction on 01.02.2023 to reserve one post out of these 80 posts till the final decision is pronounced; and

Whereas, another petition pending before Central Administrative Tribunal at Jammu, was disposed of in OA No. 61/80/2023 titled Sudha Verma vs UT of J&K & Ors, with the following directions:

"...the Original Application is disposed of with a direction to Chairman, Services Selection Board, Jammu (Respondent No.2 herein) to decide the applicants' objections while keeping in view the provisions of the schedule annexed with the '2016 Act' before finalising the select list of Class-IV candidates under PWD Category. Before taking such a decision, the applicants shall be afforded an opportunity of being hearing..."

Whereas, a Notice was accordingly served to these petitioners vide No. JKSSB-LEG/72/2023-03 (E-7117922) dated 13.04.2023 to present themselves before the Board on 17.04.2023 at Jammu/Srinagar office of JKSSB to present their objections to the Provisional Selection List for these aforementioned Class-IV posts. Accordingly, the Board in its 225th meeting held on 04.05.2023 decided as under:

"The Board perused the record placed before it and it was observed that one post among these 80 vacancies of Class-IV, advertised vide Notification No.01 of 2020 dated 26.06.2020, would need to be kept reserved for relevant cadre/category in compliance to the directions in O.A. No 39/2023 titled Mehak Ali Makroo Vs General Administration Department. Also, taking note of the fact that an opportunity of being heard has been afforded to the applicants in compliance to the directions of the Hon'ble Central Administrative Tribunal, Jammu in OA No.61/80/2023 titled Sudha Verma & Ors Vs UT of7&K &Ors, the Board advised that a consideration order shall be issued in this matter."

The Board further decided that the Legal Section shall examine the issues involved in OA titled 0.A 159/2022 titled Vishal Singh Vs UT of7&K and Others, which is currently pending in the Hon'ble CAT, Jammu and advise whether there is any hitch in notifying the Final Selection List in respect of these posts of Class-IV earmarked to the Persons with Disabilities {sub-category of Deaf & Hard of Hearing), given that there are no interim directions in the matter."

Whereas, the Board in light of directions by the Hon'ble Central Administrative Tribunal in *OA No.61/80/2023 titled Sudha Verma & Ors Vs UT of J&K & Ors,* vide Consideration Order No. 108-SSB of 2023 dated 02.06.2023, rejected the claim of the petitioners having found it devold of merits in light of the extant rules governing

Whereas, in OA No. 159/2022 titled Vishal Singh Vs UT of J&K and Others with regard to the Selection for the Class-IV posts, advertised vide Notification No. 01

2020 dated 26.06.2020, it has been averred that the J&K Services Selection Board while considering the selection for these posts has ignored the Horizontal Reservation applicable to the Persons with Disabilities and have sought that the same may be considered under the provisions of the Rights of Persons with Disability Act, 2016. The Board deliberated the issues raised in the instant OA in the 224th Board meeting which decided as under:

"...The Board further decided that the Legal Section shall examine the issues involved in OA titled O.A 159/2022 titled Vishal Singh Vs UT of J&K and Others, which is currently pending in the Hon'ble CAT, Jammu and advise whether there is any hitch in notifying the Final Selection List in respect of these posts of Class-IV earmarked to the Persons with Disabilities (sub-category of Deaf & Hard of Hearing), given that there are no interim directions in the matter."

Whereas, the matter was, accordingly, taken up with the Legal Section which opined that there will be no legal impediment in notifying the Final Selection List of hearing category but the same shall be subject to the outcome of any OA/writ petition pending before the Hon'ble Tribunal/ Hon'ble High Court respectively; and

Whereas, in yet another OA No. 443/2023 titled Riyaz Ahmad Bhat Vs UT of J&K & Ors, the petitioner has submitted that in pursuance to notification No. 01/2020 dated 26.06.2020 he has applied for the Class-IV posts, as he was fulfilling all the requisite criteria, besides was also having a disability certificate in the category "Hearing Impairment" but has not been considered for Selection in in the Provisional Selection List for these posts notified on 03.01.2023. The Hon'ble Tribunal disposed of the OA vide order dated 02.06.2023 with the following directions:

"In view of the limited prayer made by the learned Counsel for the applicant, the respondents are directed to consider the representation dated 03.01.2023, filed by the applicant, and decide the same within two week's time, in accordance with rules, by a speaking and reasoned order".

Whereas, vide Order No. 125-SSB of 2023 dated 10.07.2023, the Board considered and rejected the claim of the petitioner as being without merits, on account of failing to meet the requisite qualification bar for these posts; and

Whereas, the Final Selection List for **80 posts**, prepared in accordance with the merit/eligibility of the candidates and as per the rules in vogue, was placed in the 229th Board Meeting, which approved it, with the decision that one post shall remain reserved in light of interim directions in case titled Mehak Ali Makroo Vs General Administration Department in O.A No. 39/2023.

Now therefore, after taking into consideration all the aforementioned factors and the rules governing the subject, the Final Selection List of the candidates for **79 Class-IV posts** (now MTS), advertised vide Notification No. 01 of 2020 dated 26.06.2020 and earmarked under Horizontal Reservation for the sub-category of Deaf & Hard of Hearing among the Persons with Disabilities, is hereby notified as per **Annexure-A** to this notification. One (01) vacancy for District Cadre, Srinagar, under OM/HCH category (School Education Department) has been kept reserved in compliance to the interim directions of the Hon'ble Central Administrative Tribunal, Srinagar, in O.A. No 39/2023 titled Mehak Ali Makroo Vs General Administration Department. It is further notified that:

- (i) The above Final Selection List shall be subject to outcome of writ petition(s)/application(s), if any, pending adjudication before any competent court of law.
- (ii) The List shall also be subject to the outcome of such *enquiry*, involving any candidate(s), as figuring in this List.
- (iii) Formal recommendations to the concerned indenting department shall be forwarded separately.
- (iv) Once the recommendations are forwarded, the candidates shall have 21 days to submit their verification rolls in triplicate before the appointing authority.
- (v) Candidates who fail to produce the requisite academic/category/additional weight-age certificates in the concerned departments at the time of verification shall lose their right to appointment at any stage.
- (vi) The candidates, whose recommendations are kept withheld, shall furnish the requisite documents within a period of one month from the date of this notification in the Board.
