Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 60 posts among other posts of Health and Medical Education Department vide Advertisement Notification No. 02 of 2021 dated 26.03.2021; and

Whereas, as per the Notification, the selection to these posts was to be made

on the basis of Written Examination only and, accordingly, the JKSSB conducted the Computer Based Test (CBT) for these posts in multiple sessions/slots w.e.f. 17.08.2021 to 25.08.2021; and

Whereas, on the basis of merit obtained by the candidates in the written test, the Document Verification was conducted vide Document verification Notice No. SSB/CoE/Health/2021/7598-7606 dated 09.11.2021, from 20.11.2021 to 04.12.2021, after JKSSB notified domain wise list of candidates falling in the consideration zone vide No. SSB/CoE/H&ME/2021/7477-84 dated 02.11.2021, both at Jammu and Srinagar by the DV Committees constituted vide Order No. 380-SSB of 2021 dated 17.11.2021 followed by Order No. 386-SSB of 2021 dated 18.11.2021 and Order No. 389-SSB of 2021 dated 18.11.2021. and separate DV committees for the left-out candidates were also constituted vide Order No. 348-SSB of 2021 dated 30.11.2021; and

Whereas, the candidates figuring in the consideration zone for the above mentioned posts were allowed to indicate the order of preference for various posts/items through a link provided on the official website of the Board <u>www.jkssb.nic.in</u> from 17.11.2021 upto 25.11.2021, vide Notice No SSB/CoE/Health/2021/7695-7704 dated 17.11.2021, the date for which was extended upto 30.11.2021 vide Notice No SSB/COE/Health/2021/7958-67 dated 25.11.2021; and

Whereas, the selection committee for preparing the selections to the aforementioned posts was constituted vide order no 344-SSB of 2021 dated 29.11.2021, that was superseded by a fresh selection committee constituted vide order no 277-SSB of 2022 dated 8.10.2022; and

Whereas, the matter was in the Hon'ble Central Administrative Tribunal against the said selection process in the case of Hilal Ahmad Bhat and others vs UT of J&K and others case, wherein, the Hon'ble CAT Srinagar clubbed TA No. 5646/2021 and TA No. 221/2021, that were disposed of by way of a common order on 15.11.2022 with the following directions:

"...In view of the above discussion, it is clear that the applicants are governed by the rules of 2009 which clearly state that the engagement of applicants was on academic arrangement basis for a period of one-year extendable upto a maximum of six years or till selection is made in accordance with the recruitment rules. The applicants had also executed an agreement/contract with the respondents that they will not claim for regularization of their services, The respondents were well within their jurisdiction and competence to issue the advertisement notification 02 of 2021 dated 26.03.2021.

With these observations, TA 5646/2021 and TA 221/2021 along with all the MAs are dismissed. All the interim orders stand

vacated. The respondents are at liberty to proceed further to complete the process of selection and appointment of candidates as per advertisement notification No 02 of 2021 dated 26.03.2021. No order as to costs"

Whereas, the petitioners aggrieved of the final order of Hon'ble CAT Srinagar, mentioned above, approached the Hon'ble High Court of J&K and Ladakh, wherein the Hon'ble High Court of Jammu & Kashmir and Ladakh at Srinagar in WP(C) No. 2682/2022, while pronouncing its Judgement on 31.01.2023, upheld the decision of the Hon'ble Central Administrative Tribunal, Srinagar Bench and maintained that:

> "...In view of the above and having regard to clear position of law enunciated by the Supreme Court in Uma Devi (3), we fully concur with the view taken by the CAT, Srinagar Bench. We find no merit in these petitions and the same are, accordingly, dismissed. The interim directions, if any, shall stand vacated. The respondents are free to conclude the selection process initiated vide advertisement Notice No. 02 of 2021"

Whereas, upon receiving the aforementioned directions from the Hon'ble High Court of Jammu & Kashmir and Ladakh on 31.01.2023, the selection committee so constituted prepared the selection list, by following the principle of *Merit-cum-Preference*, that was approved in the Board in its 221st Meeting held on 14th March, 2023, and subsequently notified vide provisional notification No JKSSB/Sel/Secy/2023/412-21 Dated 20.03.2023; and

Whereas, the candidates aggrieved with this provisional selection were asked to represent within 3 days from the date of the aforementioned notification through the email address **healthandnursing.022021 @gmail.com**, in response to which a total number of 105 representations were received leading to a significant change in cadre allocation after consideration of all the received grievances/complaints, which prominently were regarding the candidates featuring in the selection list being in possession of higher qualification than prescribed and regarding the recognition status of the institutions; and

Whereas, the aforementioned facts were presented before the Board in its 232nd Board Meeting, which after due deliberations approved the same and the Revised Provisional Selection List was notified vide notification No. JKSSB/SelSecy/2023/826-835 dated 18.08.2023; and

Whereas, the candidates aggrieved with this Revised Provisional selection were again asked to represent within 3 days from the date of the aforementioned notification through the email address <u>healthandnursing.022021@gmail.com</u>, in response to which complaints and representations were again received, that were examined in light of the extant rules; and

Whereas, the Hon'ble Central Administrative Tribunal, Srinagar Bench, in OA No 737 of 2023, titled Ashaq Hussain Khanday Vs UT of J&K and Ors, in its order dated 15.09.2023 has directed that:

"...In view of the limited prayer made by the Learned Counsel for the applicant, the respondents are directed to consider the objections filed by the applicant within a period of two weeks from today, by passing a speaking and reasoned order. Till then no further process shall be made..."

Whereas, in view of the OA mentioned above, the only post under item No. 241 (Mistry, Div. Cadre, Kashmir) of the notification No.02 of 2021, has been kept reserved subject to the outcome of the said OA; and
