

The documents verification/ scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/ Degree certificates and ascertaining genuineness/ validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/ Appointing authority.

The Selection of the candidates has been made on the basis of Self-declaration/ Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/ certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
