NOTIFICATION

Subject: Selection List for the post of Foreman Grade-I (Mechanical), Divisional Cadre, Jammu in Public Works Department, advertised vide Notification No. 05 of 2020, Dated 24.12.2020, under item no 142.

Whereas, the public works department vide indent no PW(R&B)/NG/124/2019, Dated 17.12.2020, among other posts requisitioned two posts of Foreman Grade-I (Mechanical) for Divisional cadre Jammu, with the following breakup: OM =1, RBA=1; and,

Whereas, these posts were advertised vide notification no 05 of 2020, Dated 24.12.2020, under item no 142; and,

Whereas, as per the indent/notification the qualification prescribed for the post is as follows:

"Three years Diploma in Mechanical Engineering from any recognized institute"; and,

Whereas, as per the notification the selection to these posts shall be made on the basis of merit obtained in written examination only; and,

Whereas, as per the criteria, the computer based test for the above said post was held w.e.f., 27.10.2021 to 02.11.2021 and 08.11.2021 to 12.11.2021 in multiple shifts/sessions; and,

Whereas, it was notified for information of the candidates that normalization procedure based on equated percentile scores shall be applied for determination of ranking of the candidates; and,

Whereas, based on the performance of the candidates in the aforesaid computer based test, the result/score sheet of the candidates was notified vide notification no: SSB/CoE/CBT/2021/8929-36, Dated 20.12.2021; and,

Whereas, the candidates falling under the consideration zone were called for Document Verification vide notification no: SSB/CoE/CBT/2022/211-18, dated: 08.01.2022; and,

Whereas, since, the common CBT examination was held for various posts falling in the same module, the Jammu and Kashmir Services Selection Board decided to seek preferences of various advertised posts to fill up the maximum vacancies issued a notification no: SSB/CoE/CBT/2022/980-88, dated: 07.02.2022 and sought online preferences from the candidates figuring in the Document verification list from 09.02.2022 to 11.02.2022; and,

Whereas, following the principle of merit cum preference, a provisional selection list along with the waiting list for the post of Foreman Grade-I (Mechanical) was issued by the board vide notification no: SSB/Secy/Sel/2022/1623-32, Dated: 23.02.2022 and it was also notified that any candidate having any sort of grievance

with regard to the provisional selection may appear before the board from 23rd to 26th February, 2022; and,

Whereas, the JKSSB received no such representation/objection against the provisional selection list issued as above; and,

Whereas, the selection list for the above said posts was placed before the board in 205th Board Meeting held on 13.07.2022, along with all relevant documents and the Board decided to release the selection list.

Now, therefore, in view of the above:

1. The selection list along with the waiting list of the candidates for the post of Foreman Grade-I (Mechanical), Divisional Cadre, Jammu in Public Works Department, advertised vide notification no 05 of 2020, under item no 142 is enclosed as Annexure - A to the notification.
2. The selection list shall be subject to the outcome of any writ petition(s), pending in any court of law of the competent jurisdiction.
3. The recommendation to the concerned indenting department shall be made separately.
