Sir,

Consequent upon the receipt of indent/requisition from the Agriculture Production and Farmer Welfare department vide indent no Agri/Coord/25/2020, Dated 16.12.2020, one post of Foreman/Sr. Mechanic and one post of Foreman/Technician under open merit category for Divisional Cadre Kashmir, the advertisement notification in respect of the said post was issued by the Board vide Notification No. 07 of 2020 dated 31.12.2020, under Item No. 306 and 307, respectively.

The qualification prescribed for the post of Foreman/Sr. Mechanic and Foreman/Technician as per the indent/requisition is as under:-

***"Three years Diploma in Mechanical Engineering from a recognized institute"***; and,

As per the criteria adopted, the Jammu and Kashmir Services Selection Board (JKSSB) conducted computer-based test (CBT) for these posts w.e.f 27.10.2021 to 02.11.2021 and from 08.11.2021 to 12.11.2021 in multiple shifts/sessions.

On the basis of the performance of the candidates in the aforesaid computer-based test, the result/score sheet of the candidates was notified vide notification no: SSB/CoE/CBT/2021/8929-36, Dated 20.12.2021. The candidates falling under the consideration zone were called for Document Verification vide notification no: SSB/CoE/CBT/2022/211-18, dated: 08.01.2022.

The CBT examination was held for various posts falling in the same module, the Jammu and Kashmir Services Selection Board decided to seek preferences of various advertised posts to fill up the maximum vacancies issued a notification no: SSB/CoE/CBT/2022/980-88, dated: 07.02.2022 and sought online preferences from the candidates figuring in the Document verification list from 09.02.2022 to 11.02.2022.

The Provisional Selection List along with the waiting list for the post of Foreman/Sr. Mechanic and Foreman/Technician in Agriculture Production and



Farmer Welfare Department, Divisional Cadre Kashmir, advertised vide Notification No. 07 of 2020, Dated 31.12.2020, under item no 306 and 307 was notified vide Notification No. SSB/Secy/Sel/2022/1609-19 dated 23.02.2022. Also, the grievance of the candidates with regard to provisional selection list were called by the Board from 23<sup>rd</sup> of February, 2022 to 26<sup>th</sup> of February, 2022.

Subsequently, the selection list prepared in light of the criteria adopted by the Board under relevant rules and on the basis of merit obtained by the candidates was approved by the Board in its 205<sup>th</sup> Board Meeting held on 13.07.2022 and the selection list was notified vide No. SSB/Sel/Secy/2022/5260-66 dated 15.07.2022.


