The Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 08 posts among other posts of Health and Medical Education Department vide Advertisement Notification No. 02 of 2021 dated 26.03.2021.

The Board in its 258th Board Meeting, approved the Final Selection list for the 08 Posts of





**Social Worker/Medical Social Worker**, Divisional Cadre, Kashmir, under Item No. 204, of Health and Medical Education Department, advertised vide Advertisement Notification No.02 of 2021 dated 26.03.2021, which was notified vide Notification No. 12 – Selection of 2024 dated 02.02.2024 and forwarded to the indenting department vide communication No. JKSSB-SD0SECY(UT)/1/2023-03(7099079) dated 05.02.2024.

The wait list in the instant selection was not forwarded as the practice of drawing up and forwarding the wait lists was discontinued owing to the issuance of S.O. 496 dated 26.09.2023, which omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof.

Vide S.O. 134 dated 28.02.2024, the earlier omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, has again been added to the mentioned rules, to which the effect has been given retrospectively, i.e., from 26.09.2023 (the date of the omission of the said sub-rule) and also vide S.O. 137 dated 28.02.2024, the Board was directed to draw up wait list(s), in respect of those select list(s) which have been issued after 07.09.2023, within a period of six-months, subject to the following conditions; namely:

- (i) That such wait list(s) are drawn within the validity period of the select lists; and
- (ii) That the resultant vacancies on account of non-joining of selected candidates have not been re-advertised.

The proposal for issuing the said wait list, as per extant rules, was discussed by the Board in its 269<sup>th</sup> Board Meeting held on 03.05.2024, which after deliberations approved the notification of the same and the aforesaid wait list was subsequently notified vide notification No. JKSSB-SD0SECY(UT)/1/2023-03(7099079) dated 03.06.2024.

Consequent upon the receipt of the above-mentioned directions from the General Administration Department, the wait list for the 08 posts (OM=5, SC=1, ST=1, RBA=1) of Social Worker/Medical Social Worker, Divisional Cadre, Kashmir under Item No. 204, of Health and Medical Education Department, advertised vide Advertisement Notification No.02 of 2021 dated 26.03.2021, is hereby notified as **Annexure-A** to this Notification.

The above Waiting Lists shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Waiting Lists shall also be subject to the outcome of any *inquiry*, involving candidate(s) figuring in this Wait List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates in the wait list has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.
