Accordingly, the Final Selection List was notified vide Notification No. JKSSB-Scry/7/2023-03 (E-7259835) dated 30.12.2023, and subsequently, forwarded to Revenue Department vide letter dated 09.01.2024. Pertinently, the wait list in the instant selection was not forwarded along-with the select list, as regulation 68 of the Jammu and Kashmir Services Selection Board (Business and Procedure) Regulations, 2022, provides that for combined selections, the wait list shall be forwarded on the request of the Indenting Department. Also, as the practice of drawing up and forwarding the wait list (s) was discontinued vide S.O. 496 dated 26.09.2023, which omitted sub rule (7) of Rule 14 of the Jammu and Kashmir Civil Services (Decentralization and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof. However, in light of S.O 134 dated 28th February, 2024, the provisions for preparation of the waiting lists were revived.

The Revenue Department, vide communication No. FCR-NGAZ/63/2024-02 (7433749) dated 14.08.2024, forwarded the requisition with the details for the post Driver of District Cadre (Jammu) under Item No. 425.

Consequent upon the above, the proposal for notifying the Wait List for the above said post was placed in the 293rd Board Meeting and following approval of the Board, was notified vide Notification No. JKSSB-Scry/7/2023-03-Part-I (E-7409766) dated 08.01.2025.
