Consequent upon the receipt of indent/requisition from various departments, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts advertised the **298** posts of Driver/Driver-I/ Driver-II Tractor Driver for UT, Divisional and various District Cadres for making direct recruitment to these posts as per following breakup:

Accordingly, the Final Selection List was notified vide Notification No. JKSSB-Scry/7/2023-03 (E-7259835) dated 30.12.2023, and subsequently, forwarded to Revenue Department vide letter dated 09.01.2024. Pertinently, the wait list in the instant selection was not forwarded along-with the select list, as regulation 68 of the Jammu and Kashmir Services Selection Board (Business and Procedure) Regulations, 2022, provides that for combined selections, the wait list shall be forwarded on the request of the Indenting Department. Also, as the practice of drawing up and forwarding the wait list (s) was discontinued vide S.O. 496 dated 26.09.2023, which omitted sub rule (7) of Rule 14 of the Jammu and Kashmir Civil Services (Decentralization and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof. However, in light of S.O 134 dated 28th February, 2024, the provisions for preparation of the waiting lists were revived.

The Revenue Department, vide communication No. FCR-NGAZ/63/2024-02 (7433749) dated 14.08.2024, forwarded the requisition with the details for the post Driver of District Cadre (Jammu) under Item No. 425.

Consequent upon the above, the proposal for notifying the Wait List for the above said post was placed in the 293rd Board Meeting and following approval of the Board, was notified vide Notification No. JKSSB-Scry/7/2023-03-Part-I (E-7409766) dated 08.01.2025.

Accordingly, the undersigned is directed to forward herewith the waiting list (**Annexure-A**) for the post of Driver, District Cadre-Jammu, under Item No 425 of Revenue Department, advertisement No.02 of 2021 dated: 26.03.2021, with the request to proceed in the matter accordingly.

The above Waiting Lists shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Waiting Lists shall also be subject to the outcome of *inquiry*, involving candidates figuring in this Wait List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing Authority.

The Selection of the candidates in the wait list has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.
