Consequent upon the receipt of the Indents dated 02.07.2021 and 23.11.2021 from the Home Department, the J&K Services Selection Board (JKSSB) vide Notification No. 06 of 2021 dated 21.10.2021, read with Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021, advertised **1200 Posts** of Sub-Inspector, Police, UT Cadre, with the following category-wise break-up:

In terms of the notified criteria, the selection for these posts was to be made on the basis of the Written Test, followed by Physical Standard Test(PST)/Physical Endurance Test(PET), with additional weight-age assigned to the candidates in possession of NCC Certificates. The JKSSB, accordingly, conducted the Computer Based Written Test (CBT) for the aforesaid 1200 posts and the Result/Score-sheet of the candidates was notified vide No. JKSSB COEOEXAM(UT)/54/2022-03 (7057013) dated 03.11.2023. This was followed by conduct of the Physical Standard Test(PST)/Physical Endurance Test(PET) of the shortlisted candidates and subsequent Document Verification of the candidates falling in the consideration zone.

The concerned Selection Committee constituted by the Board, having regard to merit/eligibility of the candidates and various other aspects attendant to the selection including medical reports from the concerned Medical Boards and as per the extant procedure/regulations, framed the Final Selection List for these posts, which was subsequently notified vide Notification No.01-Selection of 2024 dated 8th of January, 2024, under endorsement No. JKSSB-Scry/26/2023-03(E-7376857) and forwarded the

same containing the recommendation of 1102 candidates, to the Indenting Department vide communication No. JKSSB-Scry/26/2023-03(E-7376857) dated 10.01.2024.

In the aforesaid forwarded Selection List, among other reserved posts, **14** (**fourteen**) posts under Social Caste category were also kept Reserved, for want of production of valid Social Caste Certificates.

The case of these candidates was subsequently examined in light of the advice conveyed by the General Administration Department vide letter No. GAD/MTG0RB-IV/07/2024(7378804) dated 30.04.2024 and deliberated in the Board, which decided to fill up these reserved posts under OSC category by considering the candidates who were otherwise figuring against these, on account of fulfilling the deficiency.

Subsequently, vide Notice issued under endorsement No. JKSSB-Scry/26/2023-03(E-7376857) dated 29.05.2024 and letter No. JKSSB-Scry/26/2023-03 (E-7376857) dated 29.05.2024, the said 14 candidates were referred to the Medical Board for undergoing their medical examination and upon receipt of satisfactory medical reports in respect of these candidates received from GMC, Jammu vide communication No. GMC/21/SMBC-SI/3220 dated 06.06.2024, the matter was again placed before the Board in its 275th meeting, which after deliberations and consideration of the matter, decided to forward the candidature of these candidates to the indenting department. The Notification in this regard was, accordingly, issued vide No. JKSSB-Scry/26/2023-03(E-7376857) dated 24.06.2024.

Accordingly, the undersigned is directed to forward herewith the recommendation in respect of the candidates for the posts of Sub-Inspector, Police (Home Department), advertised vide Notification No. 06 of 2021 dated 21.10.2021 and Notice No. SSB/Secy/2021/7926-42 dated 24.11.2021, Item No. 668, as per **Annexure-A** to this communication.

The above Selection List shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Selection List shall also be subject to the outcome of any inquiry, involving candidate(s) figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
