IMPORTANT NOTICE

Subject: Re-scheduling/Postponement of Document Verification in Phase- 2nd of candidates for Class-IV posts advertised vide Notification No. 01 of 2020.

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) vide Notification No. SSB/Sel/Secy/2022/1230-38 dated 11.02.2022 called additional candidates for filling the balance Class-IV posts advertised vide Notification No. 01 of 2020 for document verification w.e.f 17.02.2022; and

Whereas, schedule of document verification for Jammu based candidates and Kashmir based candidates was notified vide Notice No. SSB/COE/2022/1305-14 dated 15.02.2022 in which some candidates were called to appear for document verification w.e.f 17.02.2022 to 28.02.2022 and also w.e.f 07.03.2022 to 12.03.2022; and

Whereas, due to inclement weather that prevailed in the Kashmir Valley, the document verification of candidates which was scheduled to be held on 23.02.2022 for Kashmir based candidates was postponed with the direction that fresh date shall be notified separately vide this office Notice No. SSB/COE/2022/1594-1604 dated 23.02.2022; and

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) is conducting the OMR based test for the posts of Accounts Assistant (Finance) on 06.03.2022 (**Sunday**) and it will not be feasible for the Board to continue the document verification w.e.f 07.03.2022 which is already notified; and

Now, therefore in view of the above the document verification of candidates for Class-IV posts who are called for document verification from 07.03.2022 to 12.03.2022 is hereby postponed. Fresh dates shall be notified separately.

The document verification of Kashmir based candidates which was scheduled to be held on 23.02.2022 and

was postponed, shall now be held on 09.03.2022 at the same time/venue and before the same document verification committees. Other terms and conditions shall remains same.
