
Whereas, the Indent/requisition letter from the Indenting Department provided for the prescribed qualification for these posts as ***"Graduation from any recognized University."***

Whereas, in terms of the notified selection criteria, the recruitment against these posts was to be made in the following manner:

"Marks obtained in the written test out of maximum marks that shall be proportionately converted into points = 80, Viva Voce = 20, Total= 100."

Whereas, the JKSSB conducted the OMR based Written examination for the said posts on **17.03.2024** and the Final Answer Key was notified. This was followed by the Document Verification-cum-Interview/Viva-voce of the candidates shortlisted vide Notice No. JKSSB-COE0EXAM(UT)/9/2024-03 (7430339) dated 15.04.2024; and

Whereas, Interview Panel for holding the Document Verification-

Interview/Viva Voce for the post of Inspector, Finance Department, UT Cadre, advertised vide Notification No. 04 of 2020 dated 16.12.2020 under Item No. 117, was constituted vide Office Order No. 180-SSB of 2024 dated 06.05.2024; and

Whereas, the Document Verification-Interview/Viva Voce for the instant post was held on 7th, 9th and 10th of May, 2024 Central Office, JKSSB, Srinagar/Jammu; and

Whereas, the Selection Committee for preparing the Selection List to the aforementioned posts was constituted vide Office Order No. 184-SSB of 2024 dated 09.05.2024; and

Whereas, fifty-eight (58) candidates, falling in the consideration zone, were shortlisted for the Document Verification-cum-Interview/Viva Voce and all fifty-eight (58) candidates participated in it; and

Whereas, the Provisional Selection List prepared by the concerned Selection Committee, in light of the extant rules and as per the score/merit of the candidates in the Written Test and Interview, was approved by the Board in its 271st Board Meeting held on 10.05.2024 and subsequently notified vide Notification No. No. JKSSB-Scry/11/2024-03(E-7475024) dated 10.05.2024, seeking objections from the candidates; and

Whereas, pursuant to the above, various representations were received in the Board, pertaining broadly to submission of documents w.r.t. withheld cases, correction in particulars etc., which were examined as per the available record/extant guidelines; and

Whereas, the proposal for notifying the Final Selection List for the aforesaid 18 posts of **Inspector Finance Department**, advertised vide Notification No. 04 of 2020 dated 16.12.2020, under Item No. 117, as prepared by the concerned Selection Committee, was placed in the Board in its 273rd meeting held on 28.05.2024, which after due consideration and deliberation on various aspects attendant to the selection, approved its notification, keeping one post reserved at Sr. No. 8 under OM, in the instant selection subject to the outcome of the O.A. 569/2024 titled Ragubir Singh Vs UT of J&K and Others.

Now, therefore, the Final Selection List of the candidates for the posts of Inspector Finance, Department, advertised vide Notification No. 04 of 2020 dated 16.12.2020, under Item No. 117, is hereby notified as **Annexure-A** to this Notification. It is further notified that:
