- 2) The interview schedule and particulars of the eligible candidates will also be available in the offices of the Administrative Officer, J&K Services selection Board, Jammu /Srinagar.
- 3) All/any additional qualifications / reserved category certificate acquired by the candidate after the last date of receipt of application forms shall not be entertained.
- 4) Mere figuring of name in the list does not entitled the candidate to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.
- 5) No separate interview call letter shall be issued to any candidate whose name figures in the said list and this notice shall be deemed to be interview call to appear before the interview committee on the schedule date & time.
