The aforesaid candidates have now produced all requisite documents, which were placed before the Board, in its 278th meeting, which decided to release the withheld recommendation of these candidates selected as Driver-II,

Jal Shakti Department, advertised vide Notification No.01 of 2023, dated 11.04.2023, Division Cadre, Kashmir.

Accordingly, the undersigned is directed to convey the above decision of the Board and release the withheld recommendation of the candidates as figuring in 'Annexure-A' to this communication for the post of Driver-II, Jal Shakti Department advertised vide Notification No. 01 of 2023, dated 11.04.2023, Divisional Cadre Kashmir, for further necessary action at your end. The other terms and conditions as conveyed vide letter No. JKSSB-Scry/04/2024-03 E-7411217 dated 03.06.2024, shall remain the same.

The above recommendation shall be subject to the outcome of writ petition(s), if any, pending disposal before any competent Court of law/ jurisdiction related to the selection. This shall also be subject to the outcome of any *inquiry*, involving candidate (s), figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of the Category/Degree certificates and ascertaining genuineness/validity etc. or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

During the process of Document Verification, the educational qualification (Minimum/ Maximum) submitted by candidates for the post has been accepted only on the basis of self declaration/ Affidavit produced by them (Copy enclosed). The appointing authority shall satisfy itself on account of this before issuing the appointment order and, if at any stage, it comes to the notice that they are in possession of qualification other than the required for the post and they have willfully submitted wrong information, the necessary action as per rules may be taken, under an intimation to the J&K Services Selection Board".

It is further requested that in case any certificate/document, during the course of verification, turns out to be fake/ fictitious, appropriate criminal proceedings against such candidates may kindly be initiated and the Board may kindly be kept informed.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation is released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.


